B1. Review of the Group's results for the current financial quarter ended 30 June 2022

For the current financial quarter ended 30 June 2022, the Group achieved unaudited revenue of RM4.62million which is higher than the revenue of RM3.22million recorded in the previous period corresponding quarter. The increase in revenue is mainly due to the higher income generated from trading in building materials.

B2. Material changes in loss after tax for the current financial quarter compared to the immediate preceding quarter

The loss after tax of the Group for the current financial quarter was approximately RM4.49million which is lower than loss after tax RM28.51million recorded in the previous period corresponding quarter. The current financial quarter losses is mainly due to losses from letting of investment properties due to COVID-19 and net losses on impairment of financial instruments.

Barring unforeseen circumstances, the Board of Directors anticipates that the financial performance of the Group will remain challenging for the financial year ended 30 June 2022.
