# B. ADDITIONAL INFORMATION PURSUANT TO BURSA SECURITIES LISTING REQUIREMENTS

### B1. Review of the Group's results for the current financial guarter ended 31 March 2023

For the current financial quarter ended 31 March 2023, the Group achieved unaudited revenue of RM0.60million which is lower than the revenue of RM4.03million recorded in the previous period corresponding quarter. The decrease in revenue is mainly due to the lower income generated from trading in building, steel and construction materials.

# B2. Material changes in (loss) / profit after tax for the current financial quarter compared to the immediate preceding quarter

The loss after tax of the Group for the current financial quarter was approximately RM7.68million which is lower than profit after tax RM0.25million recorded in the previous period corresponding quarter. The decrease in profit is mainly due to the lower revenue generated from trading in building, steel and construction materials and net losses on impairment of financial instruments. The future possibility reversal of impairment loss will reflects an increase profit from potential of financial instruments since the date when the impairment loss for the asset.

### B3. Current year prospect

Barring unforeseen circumstances, the Board of Directors anticipates that the financial performance of the Group will remain challenging for the financial year ending 30 June 2023.

#### B4. Profit forecast / Profit guarantee

There was no profit forecast or profit guarantee in respect of the current financial year.

## B7. Status of corporate proposals announced

The Company proposed change the name to Rekatech Capital Berhad has been approved by the Companies Commission of Malaysia (CCM) on 23 September 2022. The Company had on 26 September 2022 applied for an extension of time and CCM has on the same day approved the reservation of name for 150 days until 22 March 2023.

The Proposed Change of Name is subject to the approval of the shareholders of the Company at the Annual General Meeting to be convened at a date to be announced later. The Proposed Change of Name, if approved by the shareholders, will be effective from the date of issuance of the Notice of Registration of New Name by the CCM.

The Company has on 9 December 2022 changed its name to Rekatech Capital Berhad.

On 13 October 2022, Bursa Securities had, vide its letter dated 13 October 2022, approved the extension of time of 6 months from 16 September 2022 up to 15 March 2023 to complete the implementation of Private Placement and extension of time of six (6) months up to 15 March 2023 to complete the implementation of the Private Placement had lapse on 15 March 2023. Accordingly, the Private Placement is deemed completed following the expiry of the Extension of Time.
