**A. EXPLANATORY NOTES PURSUANT TO MFRS 134: INTERIM FINANCIAL REPORTING**

**B. ADDITIONAL INFORMATION PURSUANT TO BURSA SECURITIES LISTING REQUIREMENTS**

**B1. Review of the Group's results for the current financial quarter ended 31 December 2023**

For the current financial quarter ended 31 December 2023, the Group achieved unaudited revenue of RM0.79million which is lower than the revenue of RM1.07million recorded in the previous period corresponding quarter. The decrease in revenue is mainly due to the lower income generated from trading in building, steel and construction materials.

**B2. Material changes in loss after tax for the current financial quarter compared to the immediate preceding quarter**

The loss after tax of the Group for the current financial quarter was approximately RM0.19million which is lower than loss after tax RM0.30million recorded in the previous period corresponding quarter. The decrease in losses is mainly due to the higher profit margin generated from property investment holding business.

**B3. Current year prospect**

Barring unforeseen circumstances, the Board of Directors anticipates that the financial performance of the Group will remain challenging for the financial year ending 30 June 2024.

**B4. Profit forecast / Profit guarantee**

There was no profit forecast or profit guarantee in respect of the current financial year.
