Comparison with the corresponding quarter in the previous year

The Group's revenue for the current quarter was RM6.133 million, a 32% decrease compared to the preceding year corresponding quarter. This decrease was mainly due to the low demand for our Automated Test Equipment ("ATE").

The Group's profit before tax ("PBT") also decreased to RM3.533 million, despite the increase in other income. This was because of the lower revenue and lower contribution from associate company.

B1 Review of performance (cont'd)

Financial period-to-date against preceding year corresponding financial period

For the current year-to-date, the Group reported revenue and PBT of RM10.708 million and RM6.117 million respectively. This represents a decline of approximately 33% in revenue and approximately 26% in PBT compared to the preceding year corresponding year-to-date, which had revenue of RM16.045 million and PBT of RM8.242 million.

The main reason for the lower revenue for the current year to date was the reduced demand for Automated Test Equipment ("ATE"). The lower PBT was mainly attributable to the lower revenue and the lower contribution from associate company.
