#### Comparison with the corresponding quarter in the previous year

The Group recorded a revenue of RM3.155 million for the current quarter, which is a 56% drop compared to the preceding year corresponding quarter. The main reason for this drop was the weak demand for our Automated Test Equipment ("ATE").

The Group's profit before tax ("PBT") also reduced to RM1.586 million due to the lower revenue and other income.

#### Financial period-to-date against preceding year corresponding financial period

The Group's revenue and PBT for the current year-to-date were RM13.863 million and RM7.703 million respectively, showing a drop of about 40% in revenue and about 36% in PBT compared to the preceding year corresponding year-to-date, which had revenue of RM23.258 million and PBT of RM11.987 million.

The main factor for the reduced revenue for the current year to date was the weak demand for ATE. The reduced PBT was mainly due to the reduced revenue and the lower contribution from associate company despite the increase in other income.

#### Comparison with the immediate preceding quarter

For the current quarter, the Group's revenue was RM3.155 million, a 49% decline from the previous quarter. The main factor for this decline was the weak demand for our ATE.

The Group's PBT also fell by 55% to RM1.586 million for the current quarter. This was due to the reduced revenue and other income.

According to World Semiconductor Trade Statistics Organization (WSTS) industry forecast in May 2023, the Global Semiconductor Market is predicted to experience a downturn of 10.3 percent in 2023 and this is anticipated to be followed by a robust recovery, with an estimated growth of 11.8 percent in 2024. Therefore, the management of Elsoft expects the demand for Automated Test Equipment ("ATE") would remain weak in the short term.

Despite the short term challenges, the Management is optimistic about the Group's future performance.
