NOTES TO THE INTERIM FINANCIAL REPORT

A. EXPLANATORY NOTES PURSUANT TO FINANCIAL REPORTING STANDARD ("FRS") 134 INTERIM FINANCIAL REPORTING

A1. Basis of Preparation

On 22 October 2008, MTB had announced that the Company's wholly owned subsidiary, Rayson Management Limited, which is held through mTouche (HK) Limited, a wholly owned subsidiary of MTB, had deregistered Teleglobal Network Limited ("TeleGlobal") under Section 291AA(9) of the Hong Kong Companies Ordinance and has ceased to be a subsidiary of the company.

B. EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENT OF BURSA SECURITIES FOR THE MESDAQ MARKET

B1. Review of Performance

For the third quarter and nine (9) months financial period ended 30 September 2008, the Group recorded revenue of approximately RM10.5 million and RM28.6 million respectively. During this nine (9) months period, the Group's core mobile messaging business continues to achieve stable growth. However, discontinued sales of Voice Over Internet Protocol ("VOIP") related products and services led to an overall lower Group revenue. The Group recorded positive EBITDA of approximately RM1.1 million and Profit Before Taxation ("PBT") of approximately RM0.3 million for the third quarter ended 30 September 2008. Excluding share of results of GMO Limited ("GMOL"), an associate company, the Group recorded PBT of RM1.7 million in Q3'08 as compared to Q3'07 of RM1.4 million.

The performance of GMOL continues to improve steadily in terms of revenue but expenses incurred relating to the conversion of the MLN issued by GMOL into ordinary shares of GMOL as mentioned in paragraph A12 as well as higher financial and operational costs resulted in losses for the period under review.

B2. Material Changes in Profit Before Taxation ("PBT") In Comparison to the Previous Quarter

The Group's performance for the financial quarter ended 30 September 2008 has improved as compared to the previous quarter with an increase in revenue and PBT with continuous production innovation, launch of new products and expanded distribution channels. The Group recorded EBITDA of RM1.1 million and PBT of RM0.3 million in the current quarter. There were no material expenses incurred in the third quarter under review. Excluding the share of results of GMOL, the Group recorded a profit of RM1.7 million.

B3. Future Prospect

Moving forward, despite the anticipated global economic crisis, the Group will focus more on its core mobile messaging services which are operationally profitable and drive our existing and new products across our eight (8) countries of operation.

Premised on the above and barring any unforeseen circumstances, the Directors of MTB are optimistic of achieving growth for the financial year 2008.
