#### A NOTES TO THE UNAUDITED INTERIM FINANCIAL STATEMENTS

#### A1 Basis of preparation

The interim financial statements is unaudited and has been prepared in accordance with the requirements of the Malaysian Financial Reporting Standard ("MFRS") 134: Interim Financial Reporting and Rule 9.22 of the ACE Market Listing Requirements ("Listing Requirements") of Bursa Malaysia Securities Berhad ("Bursa Securities").

# B ADDITIONAL INFORMATION REQUIRED BY THE ACE MARKET LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

#### **B1** Review of performance

The Group recorded revenue of RM71.2 million and RM459.5 million for the current financial quarter ("CFQ") and year-to-date ("YTD") respectively. The Group's gross profit margins for the CFQ and YTD were9.8% and 10.7% respectively. These margins were much lower than those of 14.3% and 16.7% achieved for the respective corresponding periods last year.

The decrease in the CFQ's gross profit year-on-year ("YoY") was mainly caused by a dropof 17.5% in the average selling price of branded products [in Renminbi ("RMB") terms] and the decline in total sales volume by 67.8%. Although the RMB average selling price of non-branded products rose 11.0% YoY, this increase was inadequate to mitigate the loss in revenue arising from the overall drop in volume. In RM terms, the YoY's drop in the average selling price for branded products was 24.5% while the average selling price of non-branded products was more or less the same YoY. These differentials between the changes in RMB and RM selling prices was due to the YoY's appreciation of RM against RMB.

The above declines in selling prices and sales volume were mainly caused by reduced demand for the Group's products amid the slowing economy in PRC as well as the loss of some major customers due to price competition. The conversion of the Group's peanut oil extraction machines to use natural gas which started in August 2016 also contributed to the reduced volume due to loss in productivity.

As a consequence of the above, the Group incurred an operating lossof RM2.2 million for the CFQas compared to a pre-tax profit of RM26.2 million for the corresponding financial quarter last year. For the current YTD, profit before tax declined by 84.0% YoY to RM16.1 million.

#### B2 Comments on material changes in profit before taxation

The reasons as detailed in Note B1 above caused the Group's revenue for the CFQ to decrease to RM71.2 million from that of RM93.0 million in the preceding financial quarter.

At the operating level and quarter-on-quarter ("QoQ"), the sales volume of non-branded products was down by 51.0% while that of branded products was higher by 61.5%. Overallvolume sold was 40.9% lower QoQ. On a positive note, the average selling price (in RMB terms) of non-branded products during the CFQ was higher by 19.3% QoQ while that of branded products was more or less the same as per the previous financial quarter.

The improved selling prices of non-branded products (constituting 75.3% of gross volume sold during the CFQ)QoQ caused the gross profit margin to improve from 6.4% in the preceding financial quarter to 9.8% for the CFQ. This together with lower net operating expenses QoQ caused the operating loss for the CFQ to decrease to RM2.7 million from that of RM4.7 million in the preceding financial quarter.

#### **B3** Commentary on prospects

PRC's economy grew 6.7% and a seasonally 1.8% QoQ in the third quarter of 2016 (based on data from National Bureau of Statistics of China). Despite these steady growth numbers, economists are expecting headwinds for PRC's economy in the coming year due to growing uncertainties in external demand, cooling measures on the housing market and signs of weaker growth in industrial output.

The conversion of the peanut oil conversion machines to use natural gas as mentioned in Note B1 is taking longer than expected and is anticipated to be completed in the first quarter of the next financial year. This has already resulted in productivity loss during the CFQ and will continue to do so until it is completed.

For the first nine months of the current financial year, RM has strengthened 6.0% against RMB. As the Group's operations are based entirely in PRC and all its transactions denominated in RMB, ceteris paribus, the RMB parity with RM in the final quarter of the current financial year will have an impact on the Group's results for the period concerned. As of 15 November 2016, RM has weakened about 1.7% against RMB since the end of the CFQ.

Premised on the above, the Group envisaged that the operating conditions for the final quarter of the current financial year will continue to be difficult. Nonetheless, the Group's performance for the said quarter is expected to improve due to stocking-up by customers for the forthcoming Chinese New Year's festivities. Barring unforeseen circumstances, the performance of the final quarter should better those of the last two preceding financial quarters. However, it is not expected to better the performance YoY.
