A EXPLANATORY NOTES PURSUANT TO MALAYSIAN FINANCIAL REPORTING STANDARD ("MFRS") 134 INTERIM FINANCIAL REPORTING

For the current quarter ended 31 May 2014, the Group recorded revenue of RM6.19 million, represents an increase of 19.18% as compared to revenue of RM5.19 million for the corresponding quarter of the preceding year.

The Group achieved a profit before taxation of approximately RM1 million for the current quarter. This represents an increase of 71.73% from the profit before taxation of approximately RM0.58 million registered in the corresponding quarter of the preceding year. The increase was mainly resulting from better sales mix of products.

For the twelve (12) months ended 31 May 2014, the Group generated total revenue of approximately RM24.67 million which represents an increase of approximately 43.68% as compared to RM17.17 million achieved in the corresponding period of the preceding year.

For the same period, the Group achieved a profit before tax of approximately RM2.79 million which represents an increase of more than 100% as compared to a profit before tax of approximately RM1.3 million registered in the corresponding period of the preceding year. The improvement was in line with volume increase and continuous cost improvement as well as better products mix.

Revenue registered in the current quarter of RM6.19 million represents an increase of 3.84% as compared to the revenue of RM5.96 million recorded in the immediate preceding quarter.

The Group's current quarter profit before taxation of approximately RM1 million has increased by 43.49% as compared to RM0.7 million in the immediate preceding quarter. This was mainly due to cost control efficiency, improvement in production processes and better sales mix as mentioned above.

B3. Commentary on Prospect for the Current Financial Year

The continued escalation of production cost due to increase in various essential cost components such as wages and electricity and also fluctuation of exchange rates may pose challenges to the Group's operations as well as its profitability.

The management shall continue to explore opportunities to enhance and improve the performance of the Group and is confident that barring any unforeseen circumstances the Group expects to achieve a favourable performance in the coming year.
