NOTES TO THE INTERIM FINANCIAL REPORT

The figures have not been audited

1. BASIS OF PREPARATION

The interim financial report has been prepared in accordance with the requirements of the Malaysia Financial Reporting Standard ("MFRS") 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board ("MASB") and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") for the ACE Market.

The interim financial report should be read in conjunction with the audited financial statements of Genetec Technology Berhad ("Genetec" or the "Company") for the financial year ended 31 March 2016. These explanatory notes attached to the interim financial report provides an explanation of the events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 31 March 2016.

The significant accounting policies and methods of computation adopted by Genetec and its subsidiary companies ("Genetec Group" or the "Group") in this interim financial report are consistent with those adopted in the financial statements for the financial year ended 31 March 2016.

2. AUDIT REPORT OF THE PRECEDING ANNUAL FINANCIAL STATEMENTS

There was no audit qualification on the annual financial statements of the Company and its subsidiaries for the financial year ended 31 March 2016

3. SEASONALITY OR CYCLICALITY OF INTERIM OPERATIONS

The business of the Group is not affected by any significant seasonal or cyclical factors for the current quarter under review.

4. UNUSUAL ITEMS AFFECTING ASSETS, LIABILITIES, EQUITY, NET INCOME OR CASH FLOWS

During the current quarter under review, there was no item or event, which affected assets, liabilities, equity, net income or cash flows that are unusual by reasons of their nature, size or incidence.

5. MATERIAL CHANGE IN ESTIMATES

There was no material change in the nature and amount of estimates reported that may have a material effect on the results for the current quarter under review.

6. ISSUANCES, CANCELLATIONS, REPURCHASES, RESALE AND REPAYMENTS OF DEBT AND EQUITY SECURITIES

There was no cancellation, repurchase, resale and repayment of debt and equity securities for the current quarter.

7. DIVIDEND PAID

No dividend was paid during the current quarter under review.

8. SEGMENT INFORMATION

Business segment information is not presented as the Group is primarily engaged in one business segment which is designing and building of customised factory automation equipment and integrated vision inspection systems from conceptual design, development of prototype to mass replication of equipment.

9. PROPERTY, PLANT AND EQUIPMENT

There was no revaluation on any of the Group's property, plant and equipment during the current quarter under review.

10. MATERIAL EVENTS SUBSEQUENT TO THE END OF THE INTERIM REPORTING PERIOD

There is no material event affecting the Group subsequent to the current quarter under review.

11. CHANGES IN THE COMPOSITION OF THE GROUP

There was no change in the composition of the Group for the current quarter under review.

12. CONTINGENT LIABILITIES OR CONTINGENT ASSETS

There were no contingent liabilities or contingent assets as at 31 March 2017 and up to the date of this report.

13. CAPITAL COMMITMENTS

There was no capital commitment for the purchase of property, plant and equipment not provided for in the interim financial statements as at 31 March 2017.

14. REVIEW OF PERFORMANCE

For the current quarter ended 31 March 2017, the Group recorded a revenue of RM18.3 million, an increase of 10.2% or RM1.7 million as compared to a revenue of RM16.6 million recorded in the preceding corresponding quarter ended 31 March 2016. The Group recorded a net loss before tax of RM2.0 million for the current quarter under review as compared to a net loss before tax of RM0.1 million in the preceding corresponding quarter ended 31 March 2016. The increase in net loss before tax for the current quarter under review was mainly attributable to impairment loss on goodwill of RM3.0 million.

The Group recorded a revenue of RM70.6 for the financial period ended 31 March 2017, a decrease of RM58.4 million or 45.3% as compared to RM129 million recorded for financial period ended 31 March 2016. The group recorded a loss before tax of RM3.6 million for the current year under review as compared to profit before tax of RM8.3 in the preceding corresponding year. The loss before tax for the current year under review was mainly attributable to lower sales volume achieved and recognition of impairment loss on goodwill of RM5.0 million.

15. COMPARISON WITH PRECEDING QUARTER'S RESULTS

Revenue of the Group increased by 27.1% to RM18.3 million for the current quarter under review as compared to RM14.4 million recorded in the immediate preceding quarter ended 31 December 2016. Despite of the increase of sales volume, the Group recorded a net loss before tax of RM2.0 million as compared to a net loss before tax of RM1.9 million for the immediate preceding quarter. This was mainly attributable to the impairment loss on goodwill of RM3.0 million recognised in the current quarter under review.

16. PROSPECTS

In view of the current economic condition, the Directors of the Group anticipate that the Group will achieve satisfactory performance for the next financial year.

17. VARIANCE ON PROFIT FORECAST/PROFIT GUARANTEE

Not applicable as Genetec has not issued any profit forecast or profit guarantee in a public document.
