A EXPLANATORY NOTES PURSUANT TO FINANCIAL REPORTING STANDARD 134 INTERIM FINANCIAL REPORTING

A1 Basis of preparation

The interim financial statements are unaudited and have been prepared in accordance with MFRS 134 Interim Financial Reporting and Paragraph 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad for the ACE Market ("Listing Requirements"). These financial statements should be read in conjunction with the Group's annual audited financial statements for the year ended 30 June 2014.

A2 The preceding year's annual audited financial statements were not subject to any qualification.

A3 Seasonal or cyclical factors

The Group's operations are not materially affected by seasonal or cyclical factors during the current quarter under review.

A4 Unusual items affecting assets, liabilities, equity, net income or cash flows

There were no unusual items affecting assets, liabilities, equity, net income or cash flows of the Group.

A5 Material changes in estimates

There were no changes in estimates of amounts reported in prior financial years, which may have a material effect in the current quarter results.

A6 Debt and equity securities

There were no issuance, cancellations, repurchases, resale and repayment of debt and equity securities for the current quarter under review save for the following:

The shareholders of Rexit had given their approval for Rexit to buy back its own shares at the Annual General Meeting ("AGM") held on 30 October 2008. The Company had obtained its renewal of authority to buy back its own shares at the Tenth AGM held on 24 November 2014. During the quarter under review, Rexit repurchased a total of 467,000 ordinary shares of its issued share capital from the open market at an average cost of RM0.38 per share. The total consideration paid for the shares bought back, including transaction costs during the current quarter amounted to RM177,872.47 and was financed by internally generated funds. The repurchased shares are held as treasury shares in accordance with the requirements of Section 67A of the Companies Act, 1965. None of the treasury shares held were resold or cancelled during the current financial quarter. As at 30 September 2014, the total number of treasury shares held was 8,022,200 ordinary shares.

A7 Dividends

No Dividend has been declared or paid in the current quarter under review.

A8 Segmental information

Segmental information is not presented as the Group is primarily engaged in only one business segment which is to provide information technology ("IT") solutions and related services.

The Group's operations are currently conducted in East Asia region.

A9 Valuation of property, plant and equipment

There was no valuation of the property, plant and equipment in the current quarter under review.

A10 Material events subsequent to the end of the quarter

There were no material events subsequent to the end of the quarter under review.

A11 Changes in the composition of the Group

There were no changes in the composition of the Group for the current quarter under review other than the acquisition of the remaining 51% equity interest in Reward-Link.com Sdn Bhd ("Reward-Link"), comprising 2,550,000 ordinary shares of RM1.00 each in Reward-Link from Karuna Capital Sdn Bhd for a cash consideration of RM3,500,000. The acquisition was completed on 17 November 2014 and Reward-Link has become a wholly owned subsidiary of Rexit thereon.

A12 Contingent liabilities

The Directors are of the opinion that during the current quarter under review, the Group has no contingent liabilities which, upon crystallisation would have a material impact on the financial position and business of the Group.

A13 Capital commitments

The Group has no material capital commitments in respect of property, plant and equipment in the current quarter under review.

A14 Significant related party transactions

During the current quarter under review, the Directors are of the opinion that the Group has no related party transactions which would have a significant impact on the financial position and business of the Group.

B1 Review of performance

For the financial year to-date ended 30 September 2014, Rexit Group recorded a revenue of RM3.545 million mainly from software sales including subscription and transaction fees, value-added hardware and system software sales. For the financial year to-date, the Group recorded a profit before tax ("PBT") of RM0.793 million and a profit after tax and non-controlling interests ("PAT") of RM0.791 million.

For the current quarter, Rexit recorded a revenue of RM3.545 million which has improved compared with the previous quarter mainly due to the increase in subscription and transaction fees, value-added hardware and system software sales. However, PBT and PAT have declined mainly due to increase in staff costs and low profit margin of hardware sales.

Barring any unforeseen circumstances, the Directors of Rexit believe that the Group's prospects for the financial year ending 30 June 2015 remains challenging.
