A EXPLANATORY NOTES PURSUANT TO FINANCIAL REPORTING STANDARD 134 INTERIM FINANCIAL REPORTING

A1 Basis of preparation

The interim financial statements are unaudited and have been prepared in accordance with MFRS 134 Interim Financial Reporting and Paragraph 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad for the ACE Market ("Listing Requirements"). These financial statements should be read in conjunction with the Group's annual audited financial statements for the year ended 30 June 2015.

A2 The preceding year's annual audited financial statements were not subject to any qualification.

A3 Seasonal or cyclical factors

The Group's operations are not materially affected by seasonal or cyclical factors during the current quarter under review.

A4 Unusual items affecting assets, liabilities, equity, net income or cash flows

There were no unusual items affecting assets, liabilities, equity, net income or cash flows of the Group.

A5 Material changes in estimates

There were no changes in estimates of amounts reported in prior financial years, which may have a material effect in the current quarter results.

A6 Debt and equity securities

There were no issuance, cancellations, repurchases, resale and repayment of debt and equity securities for the current quarter under review save for the following:

The shareholders of Rexit had given their approval for Rexit to buy back its own shares at the Annual General Meeting ("AGM") held on 30 October 2008. The Company had obtained its renewal of authority to buy back its own shares at the Eleventh AGM held on 27 November 2015. During the quarter under review, Rexit repurchased a total of 1,530,100 ordinary shares of its issued share capital from the open market at an average cost of RM0.41 per share. The total consideration paid for the shares bought back, including transaction costs during the current quarter amounted to RM630,553.93 and was financed by internally generated funds. The repurchased shares are held as treasury shares in accordance with the requirements of Section 67A of the Companies Act, 1965. None of the treasury shares held were resold or cancelled during the current financial quarter. As at 30 September 2015, the total number of treasury shares held was 9,822,300 ordinary shares.

No Dividend has been declared or paid in the current quarter under review.

B1 Review of performance

For the financial year to-date ended 30 September 2015, Rexit Group recorded a revenue of RM4.144 million mainly from software sales including subscription and transaction fees. For the financial year to-date, the Group recorded a profit before tax ("PBT") of RM2.059 million and a profit after tax and non-controlling interests ("PAT") of RM1.660 million.

For the current quarter, Rexit recorded a revenue of RM4.144 million, a marginal decline compared with the previous quarter mainly due to the decrease in value-added hardware and system software sales. PBT has decreased in line with the decline in revenue. However, the lower PAT is attributed to higher tax expense resulting from the expiry of a subsidiary's pioneer status incentive on 24 March 2015 which includes exemption on statutory business incomes.

B3 Prospects

Barring any unforeseen circumstances, the Directors of Rexit believe that the Group's prospects for the financial year ending 30 June 2016 remains challenging.
