B1. PERFORMANCE REVIEW

The Group generated revenue of approximately RM9.29 million for the current quarter under review, representing a 20.95% increase in comparison to the revenue of approximately RM7.68 million recorded in the preceding quarter year corresponding period ("PYCP"). The Group's higher revenue was mainly due to increase in overseas and local sales. The Group achieved a profit before taxation ("PBT") of approximately RM2.12 million for the current quarter ended 31 December2014 representing a 34.73% increase compared to PBT of approximately RM1.58 million recorded for the PYCP. An increase in PBT was mainly due to increase in sales.

B2. COMPARISON WITH PRECEDING QUARTER'S RESULTS

The Group's revenue for the current quarter under review of approximately RM9.29 million was higher as compared to approximately RM8.61 million achieved in the immediate preceding quarter ended 30 September 2014, representing an increase of about RM0.68 million or 7.86%. However, the Group recorded a profit before tax of RM2.12 million for the current quarter ended 31 December 2014 as compared to PBT of RM2.73 million in the preceding quarter. The decrease in PBT was mainly due to higher cost of sales.

B3. COMMENTARY ON PROSPECTS

The Board is of the view that the financial performance and prospects of the Group will be challenging in the remaining financial year. As a result, the Board will continue to exercise caution in managing the business.
