# PART B – EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD FOR THE MAIN MARKET

#### **B1. Review of performance**

For the quarter ended 31 July 2016, the Group recorded a revenue of RM0.25 million as compared to RM29.76 million in the immediate corresponding quarter of the preceding period. The decrease in the Group's revenue by RM29.51 million was mainly due to the decreased contribution from Solar Division in the current quarter.

The Group registered a loss before taxation ("LBT") for the quarter ended 31 July 2016 of approximately RM0.15 million as compared to RM5.55 million in the immediate corresponding quarter of the preceding period. The LBT in the reporting quarter was mainly due to the depreciation of property, plant and equipment and operating costs incurred.

The Group obtained a revenue of RM0.250 million for the current quarter under review as compared to the immediate preceding quarter's revenue of RM 1.348 million. The decrease of revenue is mainly due to the decreased contribution from the Group's Construction and Property Development Division. The Group recorded a loss before taxation of approximately RM 0.146 million for the current quarter as compared to a loss before taxation of RM 0.692 million for the preceding quarter. The lower loss in the current quarter under review as compared to the immediate preceding was mainly due to successful implementation of cost tightening programme.

#### **B3. Current Prospects**

The Group is currently experiencing a challenging time due to the increased competition and weaker demand brought about by the depreciation of the Malaysian Ringgit and the implementation of the Goods and Services Tax (GST).

With the completion of the debts restructuring plan dated 9 January 2015 and private placement dated 29 January 2016 and ESOS shares issued on 31 Mar 2016, the financial position of the Group is expected to significantly improve and the management will be able to fully concentrate on strengthening and growing the business.

Barring any unforeseen circumstances, with the diversification into the construction and property development industry, the Group is confident of achieving better performance.

The Group is not subjected to any profit forecast or profit guarantee.
