B1. Review of the Group results for the current quarter ended 30 June 2017

For the current quarter ended 30 June 2017, the Group recorded revenue of RM4.55 million and pre-tax loss of RM0.59 million compared to revenue of RM5.57 million and pre-tax loss of RM1.10 million respectively, for the preceding year's corresponding quarter ended 30 June 2016.

The lower revenue recorded in the quarter was attributed to lower progress billing of for installation and commissioning projects. The lower pre-tax loss albeit lower revenue was due to higher profit margin for recurring maintenance project & better cost control in the current quarter.

B2. Variation of results against immediate preceding quarter

For the current quarter ended 30 June 2017, the Group recorded revenue of RM4.55 million as compared to revenue of RM4.46 million recorded in the immediate preceding quarter.

The Group recorded a pre-tax loss of RM0.59 million in the current quarter compared to a pre-tax loss of RM0.18 million in the immediate preceding quarter mainly due to one off higher administrative expenses in the quarter.

B3. Prospects

The Group's business segments are expected to operate in a challenging environment in 2017. However, the Group will strive to continue to improve its efficiency and focus on better margin product mix to improve the Group's profitability.

B4. Profit forecast

There was no profit forecast or profit guarantee issued by the Group and the Company for the current quarter.
