Due to the change in financial year, the Group has provided the analysis on performance for reference purpose.

For the 9 months ended 30 April 2019, the Group's revenue was RM29.1 million compared to RM31.8 million during the same period in 2018. The decrease of 8.5% was a result of lower sales from plantation and non-plantation products. However, the Group recorded profit before taxation of RM5.6 million compared to profit before taxation of RM0.8 million in the financial period ended 30 April 2018 mainly due to bargain purchase of RM6.2 million arising from the acquisition of SND Teguh Enterprise Sdn Bhd and Pullah PC Daud Sdn Bhd partially offset by loss on disposal of associate amounting to RM2.0 million.

18. Variation of results against immediate preceding quarter (Quarter ended 30 April 2019 versus 31 January 2019)

Due to the change in financial year, the Group has provided the analysis on performance for reference purpose.

The Group recorded a higher profit before taxation of RM4.2 million in the quarter ended 30 April 2019 as compared to profit before taxation of RM0.3 million in quarter ended 31 January 2019.
