17. Review of Group performance (YTD Q2 FYE 2021 versus YTD Q2 FYE 2020)

For the second quarter ended 30 June 2021, the Group's revenue was RM19.4 million compared to RM12.2 million recorded in the same period in 2020. The increase of 59.0% was mainly due to higher sales from household goods operating segment. The Group recorded a higher profit before taxation of RM4.2 million compared to profit before taxation of RM3.7 million for the corresponding period in 2020 mainly due to better margins and higher contribution from the household goods operating segment.
