## 17. Review of Group performance (YTD Q2 FYE 2023 versus YTD Q2 FYE 2022)

For the second quarter year to date ended 30 June 2023, the Group's revenue was RM18.9 million compared to RM30.4 million recorded during the same period in 2022. The decrease of 37.8% was mainly due to lower sales from household goods operating segment arising from lower demand from export markets. The Group recorded a loss before taxation of RM5.2 million compared to profit before taxation of RM5.1 million for the corresponding period in 2022 mainly due to lower contribution from household goods operating segment and low rubber price.

# 18. Variation of results against immediate preceding quarter (Q2 FYE 2023 versus Q1 FYE 2023)

The Group recorded a loss before taxation of RM4.1 million in the current quarter ended 30 June 2023 compared to loss before taxation of RM1.0 million in the immediate preceding quarter ended 31 March 2023. The higher loss recorded in the current quarter was mainly due to lower sales and contribution from the household goods and plantation inputs operating segment.

## 19. Future prospects

The business environment continues to be challenging due to continuing geopolitical risks and high inflationary environment impacting consumer demand resulting in lower sales from the household goods operating segment. Lacklustre rubber price have also impacted both the plantation inputs and rubber sales of the Group. The Group will continue to monitor the situation and take necessary measures to reduce any adverse impact to the Group.

Examples of such measures include but are not limited to cost rationalisation and efficiency improvements at the household goods and plantation business segments, efforts to expand the Group's customers base in new and existing territories, and upgrading of equipment and infrastructure.
