B1 Review of performance

For the current quarter ended 31 March 2010, JFT Group recorded a turnover of RM2.39 million and profit before tax ("PBT") of RM0.59 million as compared to the same quarter last year of RM0.27 million and loss before tax ("LBT") of RM1.06 million respectively. The higher revenue and PBT were mainly attributed to the recovery of the semiconductor industry and stronger demand for G2 Kelvin test probes.

For the cumulative period to date, the Group's revenue increased by 83% to RM5.70 million from RM3.11 million and PBT increased by 227% from deficit of RM0.55 million to surplus of RM0.70 million as compared to the preceding year corresponding period. The higher revenue were mainly attributed to the reasons as explained above. The higher PBT margins are due to economies of scale as revenue increases.

For the current quarter ended 31 March 2010, JFT Group revenue increased by 39% and PBT increase by 486% as compared to the preceding quarter of RM1.73 million and RM0.10 million respectively. The increase in revenue and profit margin were mainly due to the reasons as mentioned in note B1.
