1. Review of performance

MPay and its subsidiaries ("Group") recorded revenue of RM1.607 million in the quarter ended 30 June 2017 ("current quarter") compared with the revenue of RM1.698 million in the preceding year corresponding quarter representing a decrease of RM91 thousand in the current quarter under review. The decrease was due to the challenging sales in the present market sentiment.

The group recorded Loss Before Tax of RM2.068 million during the current quarter compared to Loss Before Tax of RM1.199 million compared to preceding year corresponding quarter. The Group recorded a Loss After Tax of RM2.091 million for the current quarter under review as compared to Loss After Tax of RM1.013 million recorded in the preceding year corresponding quarter. The increase in the Loss after tax was due to increase of the Administrative and General Expenses.

The Group cash position and liquidity remains healthy with short term fund and cash balance of about RM58.2 million. The total order book as at 30 June 2017 was RM0.397 million.

Under the current financial quarter review, the Group recorded revenue of RM1.607 million, representing a increase in revenue of RM184 thousand as compared to RM1.423 million recorded in the immediate preceding quarter. The increase of the revenue was due to Pin & Pad, Parcelpay revenue. The Group's Loss Before Tax for the current quarter under review was RM2.068 million, as compared to the Loss Before Tax of RM RM2.324 million recorded in the immediate preceding quarter. This was due to the fact that increase in revenue, other income and decrease in the Cost of sales.

3. Prospects of the Group

The Group launched MPay ePayment and eMoney related products and services such as MPay Balance Virtual Account, MPay Mastercard Prepaid Card and Domestic Remittance Services. These products are potential growth in the Electronic Payment Solutions industry.

The registered Recognised Market Operator (P2P) entity i.e. QuicKash Malaysia Sdn Bhd (Quickash) is targeting to be operational before end of Q3 2017 and is assisting to help qualified Malaysia incorporated Small Medium Enterprises (SMEs) and micro-enterprises to raise total financing.

ManagePay Services Sdn Bhd ("MPSB"), a wholly-owned subsidiary of MPay, had on 24 May 2017 received conditional approval from the Moneylenders and Pawnbrokers Division of Ministry of Urban Wellbeing, Housing And Local Government on MPSB's application dated 28 February 2017 for money lending license to operate as money lender under the Moneylenders Act 1951 [Act 400]

subject to the conditions to be fulfilled by MPSB within six (6) months from the Letter of Approval dated 12 May 2017 ("Conditional Approval").

The Conditional Approval allows MPSB to seek further approval from various authorities to roll out payment card based credit product such as the issuing of MPay MasterCard credit card for small and medium-sized enterprises ("SMEs") and individuals, over and above the MPay's Quickash Peer-to-Peer (P2P) financing platform, which also target underserved SMEs segment but not individual, and is scheduled to be launched soon.

The Group continues to increase the number of revenue streams on top of the acquiring and the card issuance business.

Premised on the above mentioned, and given the outlook of the finance industry and business aligned to the payment card reform framework advocated by BNM and Securities Commission Malaysia (SC), the Group is well positioned to capture a substantial share of the growth of the payment industry in the coming few years.
