A. EXPLANATORY NOTES PURSUANT TO MALAYSIAN FINANCIAL REPORTING STANDARDS (MFRS 134):

A1. Basis of Preparation

The interim financial statements are unaudited and have been prepared in accordance with MFRS 134: Interim Financial Reporting and Appendix 9B of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") ("Listing Requirements").

The Group's revenue for the current quarter three (3) months ended 30 June 2014 ("2Q2014") decreased marginally by RM0.23 million or 2.20% compared to the corresponding quarter ended 30 June 2014 ("2Q2013"). For six (6) months financial period ended ("FPE") 30 June 2014, the Group's revenue decreased by RM1.39 million or 6.89% compare to the FPE 30 June 2013. The decrease in revenue was mainly due to the decrease in revenue generated from the sales of lubricant, paint and solvent products as well as schedule waste collection. Nevertheless, this is offset by the stronger sales of recycled fuel oil products from existing customers.

The Group's gross profit margin for the 2Q2014 and the FPE 30 June 2014 were lower by 12% and 7% respectively as compared to the corresponding periods 2Q2013 and FPE 30 June 2013. This was mainly due to the declining revenue generated from high profit margin products such as lubricant and collection of schedule waste. In addition, the additional operating cost and finance cost incurred in new Pulau Indah Plant since its commissioning in the fourth quarter of the FYE 31 December 2013 has also affected the profitability of the Group.

As a result of the abovementioned weaker performance in sales and gross profit margin, the Group has incurred a loss before taxation for the 2Q2014 and FPE 30 June 2014 as compared to the corresponding periods 2Q2013 and FPE 30 June 2013.

Revenue for the Group increased by RM1.93 million or 22.82% from RM8.43 million recorded for the preceding quarter compared to RM10.36 million for the current quarter under review. The increase in revenue was mainly due to the increase in sales of recycled fuel oil. However, the revenue generated from high profit margin segment, such as schedule waste collection and lubricant products has declined by 20% and 64% respectively as compared to the preceding quarter. This has impacted the overall product mix gross profit margin of the Group and recorded lower by 12% as compared to the preceding quarter's gross profit margin of 31%.

The Group's has incurred a loss before taxation of RM0.48 million for the current quarter under review as compared to a profit before taxation of RM0.31 million in the preceding quarter mainly due to the decline in gross profit margin as stated above as well as additional cost incurred in marketing and promotional activities for the current quarter under review.

B3. Prospects

With the commencement of commercial production of its new production facility in Pulau Indah in the fourth quarter of the FYE 31 December 2013, the outlook of the Group's is expected to be positive. Notwithstanding the adverse financial results of the current quarter under review, the Group has also achieved positive results in its efforts to expand and reinforce its key raw material supply chain as well as its expansion of its customers and suppliers network. This will enhance the availability of feedstock supply.

However, intense market competition, constant pressure for competitive pricing and fluctuations in feedstock prices may have an adverse impact on the Group's earnings and profitability. Notwithstanding the above, the Group will continue to focus on productivity enhancement, marketing efforts and reinforcement of its key raw material supply chain in view of achieving positive results.

As a result of the challenges mentioned above, the Board of Directors anticipates that the financial year ending 31 December 2014 will be a challenging one.

The Group's effective tax rate for the current financial quarter under review was higher than the statutory tax rate due to certain expenses not deductible for tax purposes and also losses in certain subsidiaries which are not allowed for set off against taxable profit in the profit making subsidiaries.

B6. Status of corporate proposals

Save as disclosed below, there are no other corporate proposals announced but not completed as at the date of this announcement:

On 10 May 2013 the Company entered into seven (7) separate Sale and Purchase Agreements with Sunway Damansara Sdn Bhd and Perbadanan Kemajuan Negeri Selangor for the acquisition of seven (7) units of office suites within an on-going development project known as "Sunway Nexis Soho" erected on the land held under Master Title PN 94193, Lot 656570 (formerly known as H.S. (D) No. 145186, PT No. 371) [formerly forming part of land under Master Title H.S (D) 103054, PT No. 33491] in the Mukim Pekan Baru Sungai Buloh, Daerah Petaling, Negeri Selangor with the total net floor areas of 1,084 square metres for a total cash consideration of RM11,145,750.00.

The proposed acquisitions are expected to be completed by first quarter of 2015.
