# NOTES TO THE CONDENSED CONSOLIDATED INTERIM FINANCIAL STATEMENTS FOR THE FINANCIAL PERIOD ENDED ("FPE") 31 MARCH 2017

# A. EXPLANATORY NOTES PURSUANT TO MALAYSIAN FINANCIAL REPORTING STANDARDS (MFRS134):

## A1. Basis of Preparation

The interim financial statements are unaudited and have been prepared in accordance with MFRS134: Interim Financial Reporting and Appendix 9B of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") ("Listing Requirements").

The interim financial statements should be read in conjunction with the Audited Financial Statements of the Company for the financial year ended ("FYE") 31 December 2016 and the accompanying explanatory notes attached to the interim financial report.

## A2. Summary of significant accounting policies

During the financial period, the Group have adopted the following amendments to MFRSs issued by the Malaysian Accounting Standards Board ("MASB") that are mandatory for current financial period:

The Group and the Company intend to adopt above MFRSs when they become effective.

The initial application of the abovementioned MFRSs is not expected to have any significant impact of the financial statements of the Group and of the Company except as mentioned below:

# MFRS 9 Financial Instruments (IFRS 9 issued by IASB in July 2014)

MFRS 9 (IFRS 9 issued by IASB in July 2014) replaces earlier versions of MFRS 9 and introduces a package of improvements which includes a classification and measurement model, a single forward looking 'expected loss' impairment model and a substantially reformed approach to hedge accounting. MFRS 9 when effective will replace MFRS *139 Financial Instruments: Recognition and Measurement*.

MFRS 9 retains but simplifies the mixed measurement model and establishes three primary measurement categories for financial assets: amortised cost, fair value through other comprehensive income and fair value through profit or loss. The basis of classification depends on the entity's business model and the contractual cash flow characteristics of the financial asset. Investments in equity instruments are required to be measured at fair value through profit or loss with the irrevocable option at inception to present changes in fair value in other comprehensive income not recycling. There is now a new expected credit losses model that replaces the incurred loss impairment model used in MFRS 139. For financial liabilities there were no changes to classification and measurement except for the recognition of changes in own credit risk in other comprehensive income, for liabilities designated at fair value through profit or loss. MFRS 9 relaxes the requirements for hedge effectiveness by replacing the bright line hedge effectiveness tests. It requires an economic relationship between the hedged item and hedging instrument and for the 'hedged ratio' to be the same as the one management actually use for risk management purposes. Contemporaneous documentation is still required but is different to that currently prepared under MFRS 139.

## MFRS 15 Revenue from Contracts with Customers

MFRS 15 replaces MFRS 118 *Revenue*, MFRS 111 *Construction Contracts* and related IC Interpretations. The Standard deals with revenue recognition and establishes principles for reporting useful information to users of financial statements about the nature, amount, timing and uncertainty of revenue and cash flows arising from an entity's contracts with customers.

Revenue is recognised when a customer obtains control of a good or service and thus has the ability to direct the use and obtain the benefits from the good or service. The core principle in MFRS 15 is that an entity recognises revenue to depict the transfer of promised goods or services to the customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services.

#### MFRS 16 Leases

MFRS 16, which upon the effective date will supersede MFRS 117 *Leases*, introduces a single lessee accounting model and requires a lessee to recognise assets and liabilities for all leases with a term of more than 12 months, unless the underlying asset is of low value. Specifically, under MFRS 16, a lessee is required to recognise a right-of-use asset representing its right to use the underlying leased asset and a lease liability representing its obligation to make lease payments. Accordingly, a lessee should recognise depreciation of the right-of-use asset and interest on the lease liability, and also classifies cash repayments of the lease liability into a principal portion and an interest portion and presents them in the statement of cash flows. Also, the right-of-use asset and the lease liability are initially measured on a present value basis. The measurement includes non-cancellable lease payments and also includes payments to be made in optional periods if the lesse is reasonably certain to exercise an option to extend the lease, or not to exercise an option to terminate the lease. This accounting treatment is significantly different from the lessee accounting for leases that are classified as operating leases under the predecessor standard, MFRS 117.

The impact of new MFRSs, amendments and improvements to published standard on the financial statements of the Group and of the Company are constantly being assessed by management.

#### A3. Auditors' report

There was no qualification on the Audited Financial Statements of Hiap Huat Holdings Berhad and its subsidiaries ("Group") for the FYE 31 December 2016.

# A4. Seasonal or cyclical factors

The principal businesses of the Group were not significantly affected by seasonal or cyclical factors during the current financial quarter under review.

No segment reporting is prepared as the principal activities of the Group are predominantly carried out in Malaysia and are engaged in a single business segment of manufacturing, recycling and refining all kinds of petroleum based products.

#### A10. Valuation of property, plant and equipment

The property, plant and equipment are stated at cost/valuation less accumulated depreciation and impairment losses. There was no revaluation of property, plant and equipment for the current quarter and financial year to date. The valuation of property, plant and equipment of the Group have been brought forward without amendment from the financial statements for the year ended 31 December 2016.

There are no capital commitments as at the reporting date that have not been reflected in these interim financial statements.

#### Performance review for the FPE 31 March 2017 versus the FPE 31 March 2016

The Group's revenue for the current quarter three (3) months ended 31 March 2017 ("1Q2017") was recorded higher by approximately RM6.53 million, representing an increase of 138.23% as compared to the preceding year corresponding quarter ended 31 March 2016 ("1Q2016"). The increase in revenue was mainly due to the increase in sales of recycled oil products by 282.51% as compared to 1Q2016 and new stream of revenue generated from the sales of recycled petrochemicals products.

The Group's gross profit margin has decreased by 15.41% from 32.72% recorded in the preceding year corresponding quarter 1Q2016. The lower gross profit margin was contributed from the recycled paint and solvent products and scheduled waste collection services due to the increase in raw material price and transportation. Both segment in aggregate has contributed approximately 20.17% of the Group's total revenue and experiencing decrease in gross profit margin by 30.83% and 29.95% respectively as compared to 1Q2016 and thus impacted the overall gross margin of the group.

The administrative expenses has decreased by 7.8% as compared to 1Q2016 due to the continuous improvement in several cost saving measures to streamline the daily operation and man power. In addition, the selling and distribution cost has also reduced by 34.03% as compared to 1Q2016. This was mainly due to the rationalisation of distribution channel which had resulted in the travelling and transportation cost savings.

The finance cost has reduced by 14.74% as compared to 1Q2016 mainly due to refinancing activity and loan settlement in the second half of 2016.

Resulting from the above, the Group's has recorded a profit before taxation of RM0.17 million for current quarter and the cumulative period as compared to a loss before taxation of RM0.53 million in the 1Q2016.

For the current quarter 1Q2017, the Group's revenue has decreased by RM1.85 million or 14.11% from RM13.10 million recorded in the preceding quarter ended 31 December 2016 ("4Q2016"). The decrease in revenue was mainly due to the decrease in sales of recycled petrochemical products by 54.59% offset by the increase of 12.25% of recycled oil product as compared to 4Q2016.

The gross profit margin has decreased from 23.91% in the 4Q2016 to 17.31% in the 1Q2017. The decrease in gross profit margin was mainly due to higher sales of recycled oil products which yielded a lower gross profit margin as well as the increase in raw material price. The sales of recycled oil products contributed approximately 64.34% (4Q2016: 49.23%) of the total sales and has impacted the overall gross margin of the Group.

The decrease of 11.23% in adminitrative expenses as compared to 4Q2016 mainly due to the decrease in staff costs which was in line with the cost saving measures to streamlining the daily operation and man power.

The reduction of 37.91% in selling and distribution cost as compared to 4Q2016 was mainly due to the rationalisation of distribution channel for greater cost saving in the travelling and transportation cost.

The finance cost has reduced by 30.00% as compared to 4Q2016. This was mainly due to refinancing activity and loan settlement in the 4Q2016.

In view of the above, the Group's PBT has decreased by RM1.05 million as compared to the 4Q2016.

# **B3.** Prospects

The outlook for the financial year ending 31 December 2017 remains challenging due to uncertainty of the oil prices and global economy. This in turn may affect the demand for the Group's products and services and correspondingly assert a downward pressure on the Group's revenue and margins. Nonetheless, the Group is constantly undertaking continuous enhancements in production efficiencies, overhead and production cost management. In addition, the Group intends to enhance its product offerings to overseas market, which is expected to generate better sales and profitability.

No profit guarantee or profit forecast has been issued by the Group previously in any public document.
