A1 Basis of Preparation

This condensed consolidated interim financial statement ("Condensed Report") is unaudited and has been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting, Paragraph 9.22 and Appendix 9B of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") ("Listing Requirements").

This is the third interim financial report on consolidated results for the third quarter ended 30 September 2017 announced by the Company in compliance with the Listing Requirements and as such, there are no comparative figures for the preceding year's corresponding period.

B1 Review of Performance

For the third quarter ended 30 September 2017, the Group achieved consolidated revenue of RM17.00 million and recorded a profit after tax of RM1.71 million for the current quarter under review. For the 9-month cumulative period ended 30 September 2017, the Group achieved consolidated revenue of RM39.08 million and recorded a profit after tax of RM4.12 million. The Group's revenue was derived from provision of building management solutions which mainly comprised ELV systems and structured cabling works.

Comparison to preceding year corresponding quarter

This is the third interim financial report announced in compliance with the Listing Requirements. There are no comparative figures for the preceding year corresponding quarter as no interim financial report was prepared for the comparative financial period concerned.

B2 Material Changes in Profit before Taxation for the Current Quarter with Immediate Preceding Quarter

For the current quarter, the Group achieved revenue of RM17.00 million, representing an increase of 60.69% as compared to the preceding quarter ended 30 June 2017. The increase was attributable to progressive revenue recognised for high value and fast track projects in the current quarter. The pre-tax profit before non-controlling interests for the Group improved from RM0.78 million for the preceding quarter to RM2.19 million for the quarter under review mainly due to higher revenue in the current quarter and listing expenses of RM815,000 incurred in the preceding quarter.

B3 Prospects Commentary

The Group will continue to focus on the following business strategies for the future growth and expansion of its business:

- (i) To increase and strengthen its market presence in Johor, while pursuing more opportunities for more projects outside Johor;
- (ii) To strengthen its ELV systems segment with the introduction of its integrated security solutions software, known as Cabnet Integrated Security Solutions; and
- (iii) To offer video monitoring solutions in collaboration with NetPosa Technologies (Hong Kong) Limited.

Existing and potential order books from current sales pipeline remain positive. However, with the expiry of pioneer status granted by Ministry of International Trade and Industry (MITI) on 7 August 2017, one of the subsidiary company ceases to enjoy the tax exemption benefit granted under the pioneer status, and will be taxed at the prevailing tax rate.
