B Additional Information Required by the Listing Requirements

B1 Group Performance Review

The Group recorded a revenue of RM75.41 million and profit before tax of RM6.24 million for the current financial quarter ended 30 September 2017. The Group's revenue is mainly derived from the construction of residential properties which accounted for about RM60.86 million or 80% of the total revenue. The balance revenue is derived from the construction of non-residential properties.

No comparative figures are presented for the preceding year's corresponding quarter as this is the third interim financial report on the consolidated results for the third quarter ended 30 September 2017 being announced by the Company in compliance with the Listing Requirements.

B2 Comparison with Immediate Preceding Quarter Results

The Group recorded higher gross profit of RM10.499 million for the current quarter as compared with RM8.988 million in the preceding quarter mainly due to higher revenue generated. The higher revenue recognition was reflective of the work progress from our sizeable order book.

B3 Prospects for the Current Financial Year

The Group operates within the construction industry in Malaysia. The outlook of the construction industry is expected to post moderate growth throughout 2017. The Board is of the opinion that the Group's financial performance will remain positive for the remaining financial year. As at 30 September 2017, the Group's unbilled order book amounts to RM634.7 million, an increase of RM15.92 compared to previous quarter.

B4 Profit Forecast

The Company did not issue any profit forecast or guarantee during the current financial quarter under review and the financial period to date.
