### A EXPLANATORY NOTES TO THE INTERIM FINANCIAL REPORT FOR THE QUARTER AND YEAR-TO-DATE ENDED 30 JUNE 2018

#### A1. Basis of Preparation

The interim financial report of the Group is unaudited and has been prepared in accordance with Malaysian Financial Reporting Standard ("MFRS") 134, Interim Financial Reporting, International Financial Reporting Standards ("IFRS") 34, Interim Financial Reporting and paragraph 9.22 of the Listing Requirements.

This is the second interim financial report on the Company's consolidated results for the second quarter ended 30 June 2018 announced in compliance with the Listing Requirements and as such, there are no comparative figures for the preceding year's corresponding period.

This interim financial report should be read in conjunction with the Accountants' Report as disclosed in the Prospectus of the Company dated 28 June 2018.

#### A2. Changes in Accounting Policies

The accounting policies and methods of computation adopted by the Group in this interim financial report is consistent with those adopted in the audited financial statements for financial year ended 31 December 2017 except for the adoption of the following Malaysian Financial Reporting Standards ("MFRS") and Amendments to MFRS which came into effect for annual periods beginning on or after 1 January 2018 and are applicable for the Group's interim financial report for the quarter and year-to-date ended 30 June 2018, as disclosed below:

#### A2. Changes in Accounting Policies (Cont'd)

MFRS 9 (IFRS issued by IASB in July 2014) replaces the existing guidance in MFRS 139 bringing together all three aspects of accounting for financial instruments as below while retaining certain principles in MFRS 139:

- classification and measurement of financial assets;
- a forward-looking impairment model; and
- a new approach for hedge accounting.

Based on the preliminary assessment of the adoption of MFRS 9, there is no material impact on the financial statements of the Group upon its application of the new impairment model in relation to the Group's financial assets which comprise mainly receivables. The assessment takes into consideration the Group's historical exposure to credit risk as well as the economic environment in which the Group is operating.

MFRS 15 establishes a single comprehensive model for revenue recognition and replaces the guidance in MFRS 111: Construction Contracts, MFRS 118: Revenue, IC Interpretation 13: Customer Loyalty Programmes, IC Interpretation 15: Agreements for Construction of Real Estate, IC Interpretation 18: Transfer of Assets from Customers and IC Interpretation 131: Revenue - Barter Transactions involving Advertising Services. MFRS 15 provides a single model for accounting for revenue arising from contracts with customers, focusing on the identification and satisfaction of performance obligations, i.e. when 'control' of the distinct promised goods or services underlying the particular performance obligation is transferred to the customers. ### B. ADDITIONAL INFORMATION REQUIRED BY THE ACE MARKET LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

#### **B1.** Review of Group Performance

For the second quarter ended 30 June 2018 (2Q18), the Group reported revenue of RM18.8 million and profit before tax of RM2.4 million. These results included an amount of approximately RM0.811 million in relation to IPO expenses.

RM16.1 million or 85.6% of 2Q18 revenue was contributed by the Hardware and Maintenance segment, while the balance RM2.7 million was derived from the Software segment.

There are no comparative figures for the quarter and cumulative period in the previous year, as this is the Group's first interim financial report on consolidated results for the second quarter ended 30 June 2018 announced in compliance with the Listing Requirements of Bursa Securities.

The Group's revenue of RM18.8 million for the current quarter under review was 36.0% higher than the RM13.8 million recorded in the previous quarter. The Group's profit before tax of RM2.4 million increased more than 7 times from RM0.3 million achieved in the previous quarter. The growth in revenue and profit before tax in 2Q18 were mainly due to higher sales of hardware products as well as increased sales of software products which yields higher margins.

#### **B3.** Prospects

The Board is optimistic of its prospects in the future, driven by a two-pronged strategy of expanding its regional footprint and increasing customer base.

The Group targets to continue its expansion in South East Asia with near term focus on the Indonesian market to complement its existing presence in Cambodia and Vietnam. This is on the back of the region's large population, rapid urbanisation and strong economic growth, which are anticipated to lead retailers to convert from manual systems to automated retail technology solutions.

The Group also intends to diversify its customer base to different retail customer types such as shopping centre retailers, airport retailers and utility retailers. The Group is also hopeful of securing opportunities to serve food and beverage (F&B) retail chains directly, leveraging on its current scope of services provided through third parties. This move would allow the Group to grow alongside the recession-proof sector and cement its position in the retail technology solutions sector.

#### **B6.** Status of Corporate Proposals

During the financial quarter, the Company was in the process of listing its entire enlarged issued share capital of RM49.31 million comprising 525,200,000 shares on the ACE Market of Bursa Securities.
