#### **B1.** Review of Performance

The Group recorded revenue of RM2.58 million for the three months ended 31 March 2013 as compared with RM2.63 million for the previous year corresponding period. The decrease is due to lower occupancy rate of the hotel operations. The Group recorded a loss before tax of RM0.12 million for the three months ended 31 March 2013 as compared with a profit of RM0.7 million for the previous year corresponding period. The loss for the current period is due to share of associate's loss.

#### B2. Comparison with Preceding Quarter's Results

The Group's recorded revenue of RM2.58 million for the current quarter from its hotel operations. The Group recorded a loss before tax of RM0.12 million for the current quarter compared with a loss before tax of RM38.8 million for the preceding quarter. The higher loss in the preceding quarter was due to higher share of associate's loss as a result of impairment made on intangible assets of the stockbroking associate.

#### B3. Year 2013 Prospects

According to BNM, Malaysia real GDP is projected to grow between 5.0% and 6.0% in 2013. BNM expects economic growth to be driven by sustained growth in domestic demand, supported by a mild recovery in net exports. The group expects the business environment to be challenging in 2013. The Group will continue to be prudent in its risk management while focusing on business development and productivity improvement in its two businesses. The Group also plans to refurbish Corus Paradise Resort, Port Dickson in 2013 in preparation for Visit Malaysia Year 2014.
