B2. Comparison with Preceding Quarter's Results

The Group's recorded revenue of RM2.28 million for the current quarter from its hotel operations as compared to RM3.1 million in the preceding quarter, the decrease was mainly due to the lower occupancy rate. The Group recorded a loss before tax of RM0.66 million for the current quarter compared with a loss before tax of RM0.07 million for the preceding quarter. The higher loss in the current quarter was due to increase in operational and financing related expenses.

B3. Year 2013 Prospects

According to BNM, Malaysia real GDP is projected to grow between 4.5% and 5.0% in 2013. The Group expects the business environment to be challenging in 2013. The Group will continue to be prudent in its risk management while focusing on business development and productivity improvement in its two businesses. The Group also plans to refurbish Corus Paradise Resort, Port Dickson in preparation for Visit Malaysia Year 2014.
