NOTES

1. Basis of Preparation

The interim financial report has been prepared in accordance with the Financial Reporting Standard ("FRS") 134 "Interim Financial Reporting" and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial report should be read in conjunction with the audited financial statements of the Group for the financial year ended 30 June 2008. The explanatory notes attached to the interim financial report provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 30 June 2008.

2. Changes in Accounting Policies

The significant accounting policies adopted are consistent with those adopted in the annual financial statements for the financial year ended 30 June 2008.

3. Qualification of audit report of the preceding annual financial statements

There was no qualification on the audit report of the preceding annual financial statements.

4. Seasonality or cyclicality of interim operations

The Group's interim operations were not materially affected by any seasonal or cyclical factors for the current quarter under review.

5. Nature and amount of items affecting assets, liabilities, equity, net income or cash flows that are unusual because of their nature, size or incidence

There were no unusual items affecting assets, liabilities, equity, net income or cash flows during the current financial period ended 31 December 2008.

6. Changes in estimates of amounts reported in prior interim periods of the current financial year or in prior financial years

There were no changes in estimates of amounts reported in the prior interim periods of the current financial period or in prior financial periods.

7. Issuance and repayment of debt and equity securities

There were no additional shares purchased by the trust set up for the ESOS ("ESOS Trust") during the current quarter under review. The total number of shares purchased by the ESOS Trust as at 31 December 2008 was 30,578,100 shares.

There were no issuances, cancellations, repurchases, resale and repayments of debt and equity securities during the financial period ended 31 December 2008.



8. Dividend paid

The final dividend of 2 sen per share less 25% taxation amounting to RM10.048 million in respect of the previous financial year was paid on 3 November 2008.

There are no material subsequent events to be disclosed till 30 January 2009 (being the latest practicable date which is not earlier than 7 days from the date of issue of this interim financial statement).

12. Changes in the composition of the Group

On 1 July 2008, the Company had acquired 100% equity interest in Raikon Building Management Co Sdn Bhd ("Raikon") for a cash consideration of RM1.8 million, based on the net assets of Raikon as at 30 June 2008.

13. Contingent liabilities or contingent assets

There are no contingent liabilities or contingent assets as at 31 December 2008.



14. Review of Performance

The Group recorded a revenue and profit before tax of RM36.1 million and RM11.2 million respectively for the current financial period as compared to RM58.3 million and RM12.5 million respectively in the preceding financial period.

The decrease in revenue and profit before tax were mainly due to the lower revenue and profit contribution from the property development segment as compared to preceding year's comparative period.

15. Material changes in profit before taxation

The Group profit before tax of RM6.6 million for the current quarter is higher compared to the immediate preceding quarter of RM4.6 million was mainly attributed to the increase share of profit after tax of associates and jointly controlled entities.

16. Prospects

The global economic crisis has brought many countries into recession and the situation is expected to worsen. The Group is taking a cautious approach to consolidate its position to withstand the adverse effect of the economic downturn.
