**DRB-HICOM BERHAD RECORDS REVENUE OF RM10.03 BILLION FOR Q3 of FY13/14**

**Shah Alam, Thursday, February 27, 2014** - DRB-HICOM Berhad (DRB-HICOM) today announced its 9 months performance for the financial period ended 31 December 2013, with Group revenue up 2.7% to RM10.03 billion compared with RM9.77 billion in the previous corresponding period.

The growth in revenue was primarily driven by the Services sector as well as higher revenue recognition from defence related projects.

The Group's pre-tax profits, excluding exceptional items (E.I.), had increased by 24.4% to RM386.56 million for the financial period ended 31 December 2013 compared with RM310.63 million reported in the previous corresponding period.

DRB-HICOM's Group Managing Director, Tan Sri Dato' Sri Haji Mohd Khamil Jamil said "In facing the highly competitive and challenging business landscape, the Group will continue in its efforts to improve operational efficiencies and managing the cost of doing business so as to remain competitive and maintain our growth momentum.

We have recently completed the acquisitions of CTRM and Konsortium Logistik Berhad to broaden the Group's business activities in the composite material manufacturing and engineering industry and the integrated logistics services respectively, which will

provide the impetus for future growth. This is in line with the Group's strategy to streamline its businesses through opportunistic and synergistic acquisitions as well through disposals to optimise and unlock value of the Group's assets and investments." added Tan Sri Dato' Sri Haji Mohd Khamil Jamil.

The Board of Directors had declared a single-tier interim dividend of 1.50 sen per share amounting to RM28.998 million for the current financial year, which will be paid on 28 April 2014.
