Notes to Interim Financial Report

A9. Material events subsequent to end of period

a) On 8 January 2015, Kuala Lumpur Kepong Berhad ("KLK") together with its wholly-owned subsidiary, KLK Premier Capital Ltd ("KLKPCL") entered into a Share Purchase Agreement ("SPA") with Mitsui & Co Ltd ("Mitsui"), a company incorporated in Japan for KLK to dispose 20% equity interest in KLKPCL to Mitsui ("Proposed Disposal") for a consideration of USD44 million (or approximately RM154 million).

KLKPCL owns 100% equity interest in Taiko Palm-Oleo (Zhangjiagang) Co Ltd ("TPOZ") which principal activities are the manufacturing and trading of fatty acids, glycerine, soap noodles and triacetin. The Proposed Disposal will allow KLK to leverage on Mitsui's business and market relationship in the People's Republic of China and technological expertise in oleochemical downstream manufacturing activities.

The Proposed Disposal is conditional on the fulfillment of various conditions and is expected to be completed in the first quarter of calendar year 2015, or any other date as mutually agreed upon by the parties.

The above proposed disposal will not have any effect on the share capital and shareholdings of the Company's substantial shareholders nor have any material effect on the net assets, earnings and gearing of the Group for the financial year ending 30 September 2015.

B. Explanatory Notes as required by the Bursa Securities' Listing Requirements

B1. Detailed analysis of performance

1st Quarter FY 2015 vs 1st Quarter FY 2014

The Group's revenue for the current quarter under review was RM3,214.55 million, 24% higher than RM2,586.84 million in the corresponding quarter last year. All segments except Investment Holdings reported higher revenues. However, Group profit before tax was 22% lower at RM318.27 million (2014: RM409.83 million). Comments on the business sectors are as follows:

Plantations sector reported a profit of RM246.24 million, 6% lower than last year's corresponding quarter's profit of RM261.60 million resulting from lower selling prices of CPO and rubber, increased CPO production cost and lower crop production.

Unrealised gain of RM26.3 million (2014: RM5.6 million unrealised loss) arising from changes in fair value on outstanding derivative contracts was recognised in the quarter.

Manufacturing sector's profit decreased 55% to RM46.39 million (2014: RM103.70 million) due to lower selling prices. Though revenue rose 12% to RM1,509.33 million (2014: RM1,353.54 million), its results were affected by negative margins from the fatty alcohol and surfactant businesses. The oleochemical division recorded a profit of RM28.80 million (2014: RM74.50 million) while the chemicals division posted a lower profit of RM16.87 million (2014: RM23.72 million).

Property Development sector registered a 5% higher profit, at RM13.87 million (2014: RM13.21 million) and revenue increased 9% to RM29.92 million (2014: RM27.43 million) from the development project in Bandar Seri Coalfields, Sungai Buloh.

B2. Comparison of current quarter's results to the preceding quarter 1st Quarter FY 2014 vs 4th Quarter FY 2014

This quarter, Group pre-tax profit increased 24% to RM318.27 million compared to the RM257.13 million reported in the preceding quarter, mainly due to higher Manufacturing profit resulting from improved margins. However, Plantations and Property Development sectors' profits were lower, affected by lower commodity selling prices and lower revenue, respectively.

B3. Current year's prospects

The Group's Plantations profit for the current financial year is expected to be lower than last financial year's in view of the current crude palm oil price. The oleochemical division expects satisfactory profit for the current financial year in anticipation of additional capacities from new plants coming on-stream and the initiatives for operational efficiencies and productivity improvement.

Overall, the Group expects a satisfactory profit for the current financial year albeit lower than that of the previous financial year.

B4. Variance of actual profit from forecast profit
