NOTES TO THE INTERIM FINANCIAL REPORT FOR THE PERIOD ENDED 30.JUNE 2017

PART A – EXPLANATORY NOTES PURSUANT TO FRS 134

1. Basis of Preparation

The interim financial statements are unaudited and are prepared in accordance with the requirements of FRS 134: Interim Financial Reporting and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 30 June 2016. These explanatory notes, attached to the interim financial statements, provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 30 June 2016.

2. Accounting Policies

The accounting policies and methods of computation adopted by the Group for the interim financial statements are consistent with those adopted in the audited financial statements for the year ended 30 June 2016.

Due to the complexity of these new standards, the financial effects of their adoption are currently still being assessed by the Group.

MASB Approved Accounting Standards, MFRSs

In conjunction with the planned convergence of FRSs with International Financial Reporting Standards as issued by the International Accounting Standards Board on 1 January 2012, the MASB has on 19 November 2011 issued a new MASB approved accounting standards, MFRSs, ("MFRSs Framework") for application in the annual periods beginning on or after 1 January 2012.

The MFRSs Framework is mandatory for adoption by all Entities Other Than Private Entities for annual periods beginning on or after 1 January 2012, with the exception of entities subject to the application of MFRS 141 Agriculture and/or IC Int. 15 Agreements for the Construction of Real Estate ("Transitioning Entities"). The Transitioning Entities are given an option to defer the adoption of MFRSs Framework and shall apply the MFRSs framework for annual periods beginning on or after 1 January 2017. Transitioning Entities also include those entities that consolidate or equity account or proportionately consolidate another entity that has chosen to continue to apply the FRSs framework for annual periods beginning on or after 1 January 2012.

Accordingly, the Group which is Transitioning Entity has chosen to defer the adoption of the MFRSs framework. As such, the Group will prepare its first MFRSs financial statements using the MFRSs framework for the financial year ended 30 June 2018.

Application of MFRS 1: First-time Adoption of Malaysian Financial Reporting Standards ("MFRS 1")

MFRS 1 requires comparative information to be restated as if the requirements of MFRSs have always been applied, except when MFRS 1 allows certain elective exemptions from such full retrospective application or prohibits retrospective application of some aspects of MFRSs.

The Group is currently assessing the impact of adoption of MFRS 1, including identification of the differences in existing accounting policies as compared to the new MFRSs and the use of optional exemptions as provided for in MFRS 1. As at the date of authorisation of issue of the interim financial statements, accounting policy decisions or elections have not been finalised. Thus, the impact of adoption of MFRS 1 cannot be determined and estimated reliably until the process is completed.

MFRS 15 Revenue from Contracts with Customers

15. Review of Performance

The performance of the Group was mainly contributed by the plantation subsidiaries.

The loss before taxation and minority interests of the plantation subsidiaries for the current quarter were due to the factors as mentioned in note 16.

16. Comparison With Preceding Quarter Results And Financial Period Todate

Current Quarter

The Group reported RM5.8 million loss before taxation and minority interests in the current quarter as compared to RM5.4 million loss before taxation and minority interests in the immediate preceding quarter. The net increase of RM0.4 million is due to increase in operating expenses.

Comparison With Preceding Quarter Results And Financial Period Todate (cont')

Year to Date

As compared to corresponding twelve month period of the financial year, there is variance between the loss before taxation and minority interests for current financial period of RM26.2 million as compared to RM20.7 million loss in the corresponding period of the last financial year. The variances of RM5.5 million loss are mainly contributed as follows despite of revenue increase by RM3.7 million:

- 1. Increase in depreciation for Malaysia land due to revaluation by 3.3 million.
- 2. Increase amortization cost of matured expenditure by RM2.3 million due to changes in basis of amortization based on total planted areas instead of total land areas.
- 3. Increase in finance costs by RM2.1 million due to changes in treatment of borrowing costs in accordance to MFRS 123, where all interest cost that relates to matured planted areas is charged to profit or loss instead of capitalised in biological assets..
- 4. Increase in operating expenses in Indonesia by RM1.5 million.

17. Current Year Prospect

The average CPO price for the current quarter was RM2,719 per metric tonne, which was lower compared to the average of immediate preceding quarter of RM3,157 per metric tonne. The current average CPO price is trading in the region of RM2,650 per metric tonne. In addition, the current shortage of foreign labours affects the harvesting/production of Fresh Fruits Bunch ("FFB").

We expect the performance of the Group to be challenging in the coming months until the recruitment of foreign labours has been optimized.

18. Variance From Profit Forecast And Shortfall In Profit Guarantee

Not applicable since the Group has not committed to any profit forecast and profit guarantee.
