The realisable value of these Excluded Assets distributable to the Group was dependent upon the occurrence of one or more uncertain future events not wholly within the control of the Company. In the second financial quarter ended 28 February 2009, the Company entered into a Settlement Agreement with the Purchaser for a full and final settlement of the respective claims, including the Excluded Assets, of each party pursuant to the Share Purchase Agreement. The sum received by the Company pursuant to the Settlement Agreement is S\$150,000 (equivalent to RM365,775).
