Notes to the interim financial report

1. Basis of preparation

This unaudited interim financial report has been prepared in accordance with the applicable approved accounting standards for entities other than private entities issued by the Malaysian Accounting Standards Board (MASB), including compliance with Financial Reporting Standard (FRS) 134, Interim Financial Reporting. This interim financial report also complies with the applicable disclosure provisions of the Listing Requirements of the Bursa Malaysia Securities Berhad.

The interim financial report has been prepared in accordance with the same accounting policies adopted in the annual financial statements for the financial year ended 31 January 2008 except for the changes in accounting policies arising from the adoption of new and revised standards as set out in Note 2.

The preparation of an interim financial report in conformity with FRS 134 requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a year to date basis. Actual results may differ from these estimates.

15. Review of performance

The Group's profit before taxation for the current quarter ended 31 January 2009 was RM0.5 million as compared to the preceding year corresponding quarter's loss before taxation of RM15.37 million. The profit was mainly due to the increase in quantity sold and the higher selling price due to a better sales mix and gain in exchange.

16. Variation of results against preceding quarter

The Group recorded a profit before taxation of RM0.5 million on a revenue of RM34.26 million for the current quarter as compared to a loss before taxation of RM0.07 million on a revenue of RM38.29 million for the immediate preceding quarter ended 31 October 2008. The profit in the current quarter was mainly due to the change in sales mix and a gain in exchange.

17. Future year prospects

With a massive global recession facing the whole world's economy, we foresee tough times ahead. However the Board is of the view that a more prudent management of production lines and an aggressive selling price campaign would reduce this negative impact and we can actually see better results in the forthcoming financial year.

The Group will continue to implement various cost control measures, diversify its product types and change its marketing strategies in order to turn around its financial position.
