B1. Review of performance

The Company registered revenue of RM4.16 million for the current financial period, a decrease of 47.42% as compared to the corresponding period in the preceding year. The Company also recorded a gross profit of RM2.80 million for the current financial year, a decrease of 55.64% compared to the corresponding period in the preceding year. The lower revenue to-date is primarily due to a decrease in the average selling price of fresh fruit bunch of oil palm ("FFB").

The Company also recorded a pre-tax profit in the financial year to date of RM3.93 million against pre-tax profit of RM7.03 million, a decrease of 44.09% compared to the corresponding period in the preceding year. The lower pre-tax profit is primarily attributable to a decrease in the average selling price of FFB and a decrease in the share of profit from associates.

B2. Variation of results against preceding quarter

The current quarter's recorded pre-tax profit of RM3.93 million on revenue of RM4.16 million as compared to pre-tax loss of RM0.58 million on revenue of RM4.08 million posted in the immediate preceding quarter. The higher revenue was mainly due to an increase in average selling price of FFB in the current quarter as compared to the immediate preceding quarter. The pre-tax profit is primarily due to higher other operating income and unrealised foreign exchange gains in the current quarter as compared to the immediate preceding quarter.

Barring any unforeseen circumstances, the directors expect the performance of the Company for the current financial year to be satisfactory.
