Part A – Explanatory Notes Pursuant to MFRS 134 Interim Financial Reporting

1. Basis of Preparation

The interim financial statements are unaudited and prepared in accordance with the requirements of MFRS 134 *Interim Financial Reporting* and paragraph 9.22 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad (BMSB). These interim financial statements also comply with IAS 134 *Interim Financial Reporting* issued by the International Accounting Standards Board.

This report should be read in conjunction with the Company's audited financial statements for the year ended 31 December 2018. The explanatory notes to the interim financial statements provide an explanation of events and transactions that are significant to the understanding of the changes in the financial position and the performance of the Company since the financial year ended 31 December 2018.

2. Significant Accounting Policies

a) Changes in accounting policies

The audited financial statements of the Company for the year ended 31 December 2018 were prepared in accordance with MFRS. The accounting policies and methods of computation adopted in these interim financial statements are consistent with those adopted in the audited financial statements for the year ended 31 December 2018.

8. Segmental Information

All forward exchange and commodity derivative contracts have maturities of one year or less after the end of the reporting period.

Forward exchange and commodity derivative contracts are transacted with accredited banks and traded on over-the-counter (OTC) markets. The related accounting policies, cash requirements of the derivatives, risks associated with the derivatives and policies to mitigate those risks are unchanged since the last financial year.

Derivatives are financial instruments classified at fair value through profit or loss. Derivative instruments are initially recognised at fair value on the date in which the derivative transactions are entered into, and are subsequently re-measured at fair values. Gains and losses from changes in fair values of these derivatives are recognised directly in profit or loss.

The fair value gains and losses on derivative financial liabilities are due to changes in price of underlying commodities and foreign exchange.

Except for the derivative financial liabilities, all other financial liabilities are measured at the amortised cost using effective interest method. Hence, no gain or loss is recognised for changes in the fair values of these liabilities.

Part B – Explanatory Notes Pursuant to Main Market Listing Requirements of Bursa Malaysia Securities Berhad

14. Review of Performance - Current financial period ended 31 December 2019

The Company recorded sales volume of 9.2 million barrels in the fourth quarter of 2019 compared to 8.6 million barrels sold in the same period in 2018. The 6% growth in volume was contributed mainly by exports amid flat domestic sales. Revenue for the quarter was sustained at RM2,914,599 thousand as the increase in sales volume was partially negated by the 7% decline in the average benchmark Dated Brent crude price of US\$63 per barrel compared to the previous year.

With crude prices slightly higher compared to the previous quarter, the Company recognized inventory holding gains during the fourth quarter of 2019 and reduction in operating expenses, partly offset by the narrowed price differentials between crude and finished products as well as the significant increase in Tapis premium over Dated Brent. Despite the volatility in the global crude price which affect regional refining margins, the Company still posted a net income of RM28,966 thousand during the quarter, a complete turn-around from the RM25,545 thousand loss incurred in the same period of prior year.

Profit before tax for the quarter is lower at RM39,669 thousand compared to RM47,803 thousand in the preceding quarter.

For the full year 2019, the Company generated operating income of RM264,887 thousand, 14% higher than RM232,875 thousand in 2018, supported by higher sales volume, savings in operating expenses and inventory holding gains. However, the reported mark-to-market valuation on inventory led to unrealized loss, resulting in net income for the year dropping by 21% to RM177,126 thousand compared to RM224,540 thousand in previous year.

15. Commentary on Prospects

The new International Maritime Organization (IMO) regulation which took effect at the start of 2020 imposed a reduction in sulfur content in marine fuels and is expected to impact the supply and demand of crude and finished products. Apart from the continuing geopolitical tensions in the Middle East and the second phase of the US-China trade deal, the coronavirus outbreak which started in early 2020 posed uncertainties in the global economic outlook. A prolonged extent of the pandemic in the region can affect demand for petroleum products as well as refining activities. Likewise, oil producing countries are likely to cut production as a measure to counter softer oil prices. On the local front, Malaysia's gross domestic product (GDP) growth is expected to slow down as the weakening global economy will continue to weigh on Malaysia's export sector.

The Company employs an adequate risk management system to mitigate these uncertainties. Amidst the challenging business environment, the Company remains focus on pursuing its long-term strategic programs such as retail network expansion, operational efficiency, and customer service experience.

16. Profit Forecast or Profit Guarantee

20. Corporate Proposals

There were no corporate proposals.

21. Changes in Material Litigation

As disclosed in Note 28 of the Company's 2018 audited financial statements, Konsortium Lord Saberkat Sdn. Bhd. (KLSSB) on 3 December 2018 filed a new claim against the Company allegedly over a breach of contract in relation to the same Agreement (the Second Suit). The amount of damages claimed was approximately RM109,184 thousand.

On 4 April 2019, High Court allowed the Company's application to strike out the Second Suit. Subsequently, on 29 April 2019, KLSSB filed an Appeal against the decision of the High Court to the Court of Appeal. The Court of Appeal on 9 January 2020 upheld the High Court decision.

On 5 February 2020, KLSSB filed an application for leave to appeal to the Federal Court against the dismissal by the Court of Appeal. The Company has instructed its external counsel to act on its behalf and does not expect any financial or operational impact as a result of KLSSB's application for leave to appeal to the Federal Court.
