When the Group loses control of a subsidiary, any interest retained in the former subsidiary will be measured at fair value with the gain or loss recognised in profit or loss. The revised standard also requires all losses attributable to the minority shareholders to be absorbed by minority shareholders instead of by the parent. The Group applied the changes of revised FRS 3 and FRS 127 prospectively and therefore there will not have any financial impact on the financial statements of the Group for financial period prior to 1 April 2011. The changes will affect future transactions with non-controlling interest.

B1. Review of the Performance of the Company and Its Principal Subsidiaries

The Group registered revenue of RM72.1 million for six months ended 30 September 2011 as compared to RM54.9 million for the preceding year corresponding period ended 30 September 2010. The increase in revenue was mainly due to higher revenue recognised by its property development segment arising from the disposal of development land during the period under review.

The Group recorded a pre-tax loss of RM11.3 million (as compared to a pre-tax loss of RM24.9 million in the preceding year corresponding period) after taking into account financing costs of RM17.5 million for the current financial year-to-date.

In the opinion of the Directors, the results for the current quarter and financial year-to-date have not been affected by any transaction or event of a material and unusual nature which has arisen between 30 September 2011 and 23 November 2011 (the latest practicable date which is not more than 7 days from the date of this Quarterly Report).

B2. Material Changes in the Quarterly Results Compared to the Results of the Preceding Quarter

The Group recorded a pre-tax loss of RM13.9 million in the current quarter (as compared to RM2.6 million profit before tax in the immediate preceding quarter). The variance was mainly attributable to the profit arising from the disposal of lands by its property development segment in the immediate preceding quarter.
