GEORGE KENT'S 1HFY12 EARNINGS GROWTH INTACT

- Pre-tax profit +14% y-o-y to RM12.2 million
- Annual production capacity of water meters to hit 2 million units by year-end
- Strong platform to sustain growth in both manufacturing & construction divisions

Puchong, 27 September 2011: George Kent (Malaysia) Berhad ("George Kent" or "The Group"), a leading engineering group specialising in manufacturing of engineering products, engineering works and construction activities, has today announced its first six months results for the financial year ending 31 January 2012.

For the period under review:

- Revenue +1% to RM72.1m from RM71.4m in 1HFY11;
- Profit before tax +14% to RM12.2m from RM10.6m in 1HFY11;
- Profit attributable to shareholders +11% to RM8.7m from RM7.8m in 1HFY11;
- Interim dividend of 2sen per share (2sen per share in 1HFY11)

George Kent's Chairman Tan Sri Dato' Tan Kay Hock said, "The results achieved were commendable in view of the global slowdown. Our exports of OEM meters were lower but the shortfall was mitigated by higher non-OEM meter exports and steady contribution from our construction activities."

"No doubt there is much concern over the current global economic outlook. Nonetheless, we remain confident that George Kent will be able to draw on its strengths to sustain its momentum in both the manufacturing and construction divisions."

"Demand for our meters from the Indo-China market is rapidly growing. George Kent continues to participate in the new tenders for meter contracts in several other countries in the region," said Tan.

On the upgrading of its plant in Puchong, Tan said, "We are on track to increase production capacity to 2 million water meters and meter housing per annum by year-end, from 1.3 million pieces. With this, George Kent has laid a solid production base to pursue higher orders abroad."

On the Infrastructure Investments, Water and Construction ("IWC") division, the Group has successfully completed Phase 1 of the upgrading of Kuala Lipis Hospital project. The two water-related infrastructure projects secured earlier are expected to contribute to the Group from the second half of this financial year.

"We are actively pursuing a tender book of several billion Ringgit in our IWC division, mainly in water and waste water related industry, healthcare and potential specialised M&E engineering works in other sectors. Some of these new contracts could materialise in the second half of our current financial year, but overall, we remain confident of securing a good portion of our tender book going forward," said Tan.

"George Kent has been working on building a stronger and more dominant growth platform for its meters manufacturing and construction divisions. The Group now has the resources and capabilities to take on higher volume in our production of meters and non-meter parts, as well as high valued infrastructure projects under the 10th Malaysia Plan and Economic Transformation Programme," he added.
