### 1. Basis of preparation

The interim financial report is unaudited and has been prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134 "Interim Financial Reporting" and the applicable disclosure provisions of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad and should be read in conjunction with the Group's audited financial statements for the financial year ended 30 June 2015. This interim financial report also complies with International Accounting Standards ("IAS") 34 "Interim Financial Reporting" issued by the International Accounting Standards Board.

#### 11. Review of Performance

For the quarter under review, the Group recorded a revenue of RM542.9 million and profit before taxation ("PBT") of RM96.1 million as compared with a revenue and PBT of RM535.6 million and RM87.2 million respectively for the corresponding quarter of the preceding year ended 30 June 2015 ("FY 2015").

For the financial year-to-date, the Group recorded a revenue of RM1,062.0 million and PBT of RM163.1 million as compared with a revenue and PBT of RM1,060.0 million and RM162.2 million respectively for the corresponding period of FY 2015.

The improvement in PBT for the quarter under review and the financial year-to-date as compared with the corresponding quarter/period of FY 2015 was mainly attributable to higher profit contribution from an associated company, partly offset by higher production cost affected by the weakening of the RM against the USD from our consumer products segment.

#### 12. Material changes in profit before taxation against the immediate preceding quarter

For the quarter under review, the Group recorded a PBT of RM96.1 million as compared with a PBT of RM66.9 million recorded in the preceding quarter, mainly higher contribution from an associated company.

#### 13. Prospects

Barring any unforeseen circumstances, the Board expects the Group's performance for both the consumer products and industrial products segment to be satisfactory for the financial year ending 30 June 2016.
