1. Basis of preparation

The interim financial report is unaudited and has been prepared in accordance with Financial Reporting Standards ("FRS") 134 "Interim Financial Reporting" and the applicable disclosure provisions of the Listing Requirements of Bursa Malaysia Securities Berhad and should be read in conjunction with the Group's audited financial statements for the financial year ended 30 June 2007.

The accounting policies and presentation adopted for this interim financial report are consistent with those adopted in the audited financial statements for the financial year ended 30 June 2007 except for the changes in accounting policies and presentation resulting from the adoption of applicable FRSs adopted by the Malaysian Accounting Standards Board that are effective for the financial period beginning after 1 October 2006 and I July 2007 as follows:-

The adoption of FRSs 107, 112, 118, 119, 124, 137 and Amendment to FRS 121 do not have any significant financial impact on the Group.

The adoption of FRS 117 has resulted in a retrospective change in the accounting policy relating to the classification of leasehold land. The up-front payments made for the leasehold land are classified as prepaid lease payments and are amortised on a straight-line basis over the remaining lease term of the land. Where the leasehold land had been previously revalued, the unamortized revalued amount of leasehold land is retained as surrogate carrying amount of the prepaid lease payments as allowed by the transitional provisions of FRS 117.

Prior to 1 July 2007, leasehold land were classified as property, plant and equipment and were stated at cost / valuation less accumulated depreciation and accumulated impairment.

(a) There was no share bought back during the quarter under review. During the financial year-to-date, the Company bought back 1,000 of its own shares from the open market for a total cash consideration of RM3,607. The total number of shares bought back as at 31 March 2008 was 8,278,800 shares and the shares are being held as treasury shares in accordance with the requirement of Section 67A of the Companies Act, 1965.

- (c) During the quarter under review and financial year-to-date, 292,300 shares were purchased by the trust set up for the ESOS ("ESOS Trust"). The total number of shares purchased by the ESOS Trust as at 31 March 2008 was 5,592,900 shares.

9. Valuations of property, plant and equipment

There were no changes in the composition of the Group during the current quarter under review, including business combinations, acquisition or disposal of subsidiaries and long-term investments, restructurings and discontinuing operations.

12. Contingent liabilities or contingent assets

There are no contingent liabilities or contingent assets as at the date of this report.

13. Review of performance

The Group registered a revenue of RM187.1 million for the quarter under review as compared with RM160.0 million achieved in the preceding year's corresponding quarter, mainly due to higher sales recorded in the concrete and building boards business segments.

The Group's profit before taxation ("PBT") for the quarter under review closed at RM48.7 million as compared with RM15.5 million registered in the preceding year's corresponding quarter. The improvement was mainly due to Southern Steel Berhad ("SSB") which reported a better profit because of higher volume and prices.

14. Material changes in PBT against the immediate preceding quarter

For the quarter under review, the Group recorded a PBT of RM48.7 million as compared with a PBT of RM34.7 million for the preceding quarter as a consequence of a better SSB performance.

15. Prospects

Barring any unforeseen circumstances, the Board expects the Group's performance to be satisfactory for the financial year ending 30 June 2008.
