14 Review of Performance of the Company and its Principal Subsidiaries

For the financial period ended 30 September 2005, Group revenue improved 16.1% to RM495.267 million from RM426.505 million in the corresponding preceding period. Profit before tax improved 29.5% to RM55.619 million from RM42.959 million in the corresponding preceding period. The improved revenue was the result of continued positive growth generated from all divisions. The improved profit before tax was mainly contributed by the aluminium can divisions and loss incurred from the PET and plastic divisions was lower at RM0.815 million as compared to loss of RM3.424 million in the preceding year quarter.

Financial

Kian Joo Canpack (Shah Alam) Sdn Bhd and Kian Joo Canpack Sdn Bhd, under the contract pack division, incurred loss of RM2.327 million for the period under review.

15 Comparison with Preceding Quarter's Results

Group revenue for the current quarter under review improved 1.4% at RM166.620 million, marginally higher than the preceding quarter of RM164.331 million. Profit before tax for the current quarter under review improved 16.4% at RM18.866 million as compared to RM16.206 million in the preceding quarter. The higher profit before tax was mainly due to the lower profit before tax in the preceding quarter as a result of the Voluntary Seperation Scheme carried out during that period.

The Group will continue to focus efforts on growth and expansion of products range and services, both in the domestic and export market. Performance for the year 2005 is expected to improve further with growing demand of aluminium can and general can, the two main divisions within the Group
