1 Basis of Preparation

The Interim Financial Statements are unaudited and have been prepared in accordance with the requirements of FRS 134 - "Interim Financial Reporting" and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

These explanatory notes attached to the interim financial statements provide an explanation of the events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2008.

2 Significant Accounting Policies

17 Review of Performance of the Company and its Principal Subsidiaries

For the financial period ended 30 June 2009, Group revenue decreased by 3.0% to RM390.7 million from RM402.7 million in the previous corresponding quarter. Profit before tax from continuing operation was lower by RM16.3 million at RM30.9 million as compared to the profit before tax of RM47.2 million in the previous corresponding quarter. The lower profit before taxation was mainly attributable to the high carried forward material cost and lower profit margin.

18 Comparison with Preceding Quarter's Results

Group revenue for the current quarter under review increased 8.4% to RM203.3 million as compared to the immediate preceding quarter of RM187.4 million. Profit before tax from continuing operation was 8.6% lower at RM14.7 million as compared to RM16.1 million in the immediate preceding quarter. The lower profit before tax was mainly attributable to lower selling price.

19 Current Year Prospects

The Board expects the performance of the Group for year 2009 to be affected by the global economic crisis. However, the Group will continue to focus its efforts to improve its operational efficiency and productivity.
