

PART A. NOTES TO THE INTERIM FINANCIAL REPORT

1. Basis of preparation

The interim financial statements are unaudited and have been prepared in accordance with the FRS 134: Interim Financial Reporting and paragraph 9.22 of the Bursa Malaysia Securities Berhad Listing Requirements.

The interim financial statements of the Group have been prepared in accordance with Malaysia Financial Reporting Standards ("MFRSs") and the Companies Act, 1965 in Malaysia and with International Financial Reporting Standards ("IFRSs") for the financial period beginning on 1 January 2012:

In the previous years, the interim financial statements of the Group were prepared in accordance with Financial Reporting Standards ("FRSs") for the transition to the MFRS, the Group has elected to apply the exemptions in MFRS 1 – First-time Adoption of Financial Reporting Standards on designation of previously recognised financial instruments and fair value measurement of financial assets or financial liabilities at initial recognition.

Other than as disclosed below, there is no material impact on the transition to MFRSs in the interim financial statements:

Under FRSs, the Group measured certain freehold land and buildings at valuation. The last valuation was in 2004. Upon transition to MFRSs, the Group elected to apply the exemption to use the previous revaluation as deemed cost under MFRSs. The revaluation reserve of RM 47,652,000 at 1 January 2011 was recognised to retained earnings.

Under FRSs, the Group measured investment properties at fair value. Upon transition to MFRSs, the Group elected to apply the exemption to use the fair value at 1 January 2011 as deemed cost under MFRSs. There is no financial effect to the Group interim financial statement.

Except as mentioned above the same accounting policies and method of computation have been applied consistently in the interim financial statement as compared with the last annual financial statement.

PART B. NOTES PER BURSA MALAYSIA SECURITIES BERHAD LISTING REQUIREMENTS

1. Performance review

Manufacturing segment

Current quarter

The manufacturing segment revenue has improved by 17.7% from RM8.40 million in the second quarter of 2011 to RM9.89 million in second quarter of 2012. The increase in revenue was mainly attributed to the increase in clay pipes sales as a result of orders from the Greater Kuala Lumpur Sewerage and Refurnishing Works project launched by the government. However, the revenue was negated by the drop in sales from the tableware division from RM0.58 million in second quarter 2011 to RM0.28 million in the current quarter due to lower revenue from government projects.

The segment recorded a higher profit before tax of RM0.49 million in the current quarter versus RM0.25 million from the same period last year due mainly to the improved sales from clay pipes.

Current year to date

The manufacturing segment revenue has improved by 12.5% from RM16.78 million in the preceding year to date of 2011 to RM18.88 million in the current year to date of 2012. The increase in revenue was mainly attributed to the increase in clay pipes sales as a result of orders from the Greater Kuala Lumpur Sewerage and Refurnishing Works project launched by the government.

However, the decline in profit before tax from RM0.70 million in 2011 to RM0.31 million in the current year was due to the drop in sales from the tableware division from RM2.20 million in preceding year to date of 2011 to RM0.62 million in the current year to date.

Trading segment

Current quarter

The trading segment revenue for the second quarter of 2012 has improved by 4.6% from RM0.79 million in second quarter of 2011 to RM0.82 million in second quarter of 2012 mainly due to higher project sales.

The loss before tax however widened from RM0.06 million in the second quarter of 2011 to RM0.32 million in the current quarter due to lower profit margin from current quarter sales as well as write off of damaged stocks of RM43,000.

Current year to date

The trading segment revenue for the current year to date of 2012 has improved by 20.5% from RM1.69 million in of 2011 to RM2.04 million in 2012 mainly due to higher project sales.

The loss before tax has improved from RM0.15 million in the preceding year to date of 2011 to RM0.06 million in the current year to date of 2012 due to overall higher margin as a result of sales of stocks which has been provided for in prior years.

Properties segment

Current quarter

The properties segment revenue for the second quarter of 2012 has declined by 39.3% from RM1.2 million in second quarter of 2011 to RM0.73 million in second quarter of 2012 mainly due to lower occupancy rate and expiry of a major tenancy.

Loss before tax widened from RM0.18 million in the second quarter 2011 to RM0.46 million in the current quarter due to the lower revenue and provision made for doubtful debts amounting to RM73,000.

Properties segment (cont'd)

Current year to date

The properties segment revenue for the current year to date of 2012 has declined by 29.1% from RM2.18 million in the preceding year to date of 2011 to RM1.55 million in current year to date of 2012 mainly due to low occupancy rate and expiry of certain tenancy agreement.

Loss before tax widened from RM0.53 million in the preceding year to date of 2011 to RM0.73 million in the current year to date was due to the lower occupancy rate and expiry of certain tenancy agreement and provision made for doubtful debts amounting to RM176,000.

2. Comparison with preceding quarter's results

The Group revenue increased from RM11.03 million in the first quarter of 2012 to RM11.44 million in the current quarter mainly due to higher sales in the clay pipes division. Current quarter performance resulted in loss before tax of RM290,000 as compared with a loss before tax of RM196,000 in the preceding quarter, due mainly to lower occupancy rate and expiry of a major tenancy in the properties segment.

3. Prospects

The Group's operating environment, principally within the ceramic building materials industry, remains difficult and challenging, with intense competition from imports sourced from cheaper cost manufacturing countries. However, the Group has taken measures to discontinue manufacture of lower margin products, strengthen its core business in the clay pipes division and undertaken cost reduction measures which should result in better performance for the Group in the remaining quarter of the financial year.
