Current Quarter vs Previous Year Corresponding Quarter

For the current quarter under review, the Group recorded a higher revenue of RM62.5 million as compared to the preceding year's corresponding quarter of RM21.6 million. The improvement in the revenue was mainly attributed to a stronger sales momentum from the Property Development segment and better revenue performance in the Mall operations.

The revenue from the Property Development segment rose significantly by RM39.2 million, an increase of almost ten-fold to RM43.7 million in the current quarter from RM4.5 million in the preceding year's quarter mainly driven by higher progressive recognition of revenue from several project developments under construction, namely, Mahogany condominum project at Kota Damansara, Dwitara Residences' condominium project at Surya, Petaling Jaya, the development of LikasVue Residences in Kota Kinabalu ("KK") and Rimba Hills' project in KK which feature a mixed development of retail shops, townhouses and terrace houses in the current quarter as compared to the revenue contribution which stem primarily from the sales of completed inventories in the preceding year's corresponding quarter.

The revenue of the Mall Operations which is situated in KK, Sabah was slightly higher by 5.3% to RM20.6 million from RM19.5 million in the previous year's corresponding quarter mainly due to the stronger retail rental income backed by higher occupancy rate.

The Group recorded a profit before tax of RM5.8 million in the current quarter as compared to RM2.7 million in the preceding year's corresponding quarter mainly attributed to profits generated from the property development division in the current quarter as compared to a loss before tax in the preceding year's corresponding quarter.

For the current quarter, the Group recorded a higher profit before tax by RM1.5 million as compared to the preceding quarter mainly attributed to cost savings achieved from the overall reduction in administrative expenses in the current quarter under review.

The Group currently has three active divisions contributing to the Group's results, namely Property Development, Mall Operations and Carpark Operations. The three divisions of the Group are progressively delivering positive performance momentum amid facing a confluence of headwinds globally, including rising inflationary and costs pressures, and higher interest rates. However, the Group expects the outlook to remain challenging in light of the persistent global economic uncertainty which is causing volatility in the currency market, albeit an improving domestic economy and a moderated inflation on the local front.
