14 Review of Performance

(a) Comparison of Results with Previous Corresponding Period

For the quarter under review, the Group's revenue decreased by 9.4% to RM236.3 million as compared with RM260.8 million recorded in the previous corresponding quarter. Pre-tax profit was down by 86% to RM3.3 million from RM24.1 million attained in the same period last year.

Lower revenue was caused by 36% fall in logs sales volume and the decrease in pre-tax profit was mainly due to 36% and 31% reduction in fresh fruit bunches (FFB) and crude palm oil (CPO) average selling prices respectively.

(b) Comparison of Year-to-date with Previous Year-to-date

For the financial year-to-date, the Group's revenue of RM796.9 million was 5% higher than RM759.0 million reported in the previous corresponding period. However, pre-tax profit had dropped by 83% to RM23.7 million as compared with RM142.6 million recorded previously.

Improvement in revenue was contributed by 11% and 24% increase of logs and plywood sales volume respectively, whereas the lower pre-tax profit was affected by:-

- 10% decrease in plywood average selling prices;
- 14% increase in plywood cost of production; and
- 26% and 22% drop in fresh fruit bunches (FFB) and crude palm oil (CPO) average selling prices respectively.

15 Comparison of Profit Before Tax with Immediate Preceding Quarter

The Group's pre-tax profit for current quarter increase by 50% to RM3.3 million from RM2.2 million reported in preceding second quarter. The improvement in pre-tax profit was contributed by the increase in average selling prices of logs during the quarter under review.

16 Commentary on Prospects

The timber prices had strengthened during the quarter under review and are expected to be maintained due to the current tight log supply condition coupled with the anticipated increase in demands from major timber consuming countries.

The oil palm division is expected to remain challenging in the near term due to the current depressed CPO prices. However, the fall in the inventory level of crude palm oil reported recently and the Government's effort to increase the biodiesel blend to 10% should help to stabilize and improve the outlook of the oil palm industries in the coming months.

The Group will continue to take prudent measures to improve operational efficiency and production yield and continue to monitor market conditions which directly impact the Group's results.
