B1. PERFORMANCE REVIEW

For the current financial period ended 30 June 2007, the Group's revenue was RM2.80 million compared to RM3.39 million in the preceding financial period ended 30 June 2006. The decrease in revenue was mainly due to the Group's inability to extract any round timber logs, as the Group was still waiting for the final issuance of permit prior to logging.

The Group recorded a loss before tax of approximately RM0.67 million compared to a loss before tax of approximately RM1.95 million for the corresponding preceding financial period ended 30 June 2006, which was mainly due to the recognition of loss from property development segment during the corresponding preceding period ended 30 June 2006.

B2. COMMENT ON MATERIAL CHANGE IN PROFIT BEFORE TAXATION

The Group's recorded a loss before taxation of approximately RM0.17 million for the current quarter as a compared to a loss before taxation of approximately RM0.49 million for the quarter ended 31 March 2007, this was mainly due to the recognition of the gain from fair value adjustment, as a result of the reclassification of a piece of vacant land pending disposal to investment property during the current quarter.

B3. COMMENTARY ON PROSPECTS

The Directors are of the view that the performance of the Group hinges substantially on the performance of its subsidiaries namely Jernih Makmur Sdn Bhd (Principal activity – logging and selling of round end timber logs) and Consistent Harvest Sdn Bhd (Principal activity – renting of shopping spaces in its shopping complex) and the joint venture with Creative Springs Sdn Bhd (Property Development). Barring any unforeseen circumstances, the Directors are confident that they will be able to improve the performance of the Group in the remaining periods of the current financial year.
