B1. PERFORMANCE REVIEW

For the current financial period ended 31 March 2009, the Group's revenue was RM1.92 million compared to RM0.94 million in the preceding financial period ended 31 March 2008. The increase in revenue was mainly due to the continuous logging activities from timber extraction segment during the financial period.

The Group recorded a lower loss before tax of approximately RM0.35 million as compared to a loss before tax of approximately RM0.53 million for the corresponding preceding financial period ended 31 March 2008.

B2. COMMENT ON MATERIAL CHANGE IN PROFIT BEFORE TAXATION

The Group's recorded a loss before taxation of approximately RM0.35 million for the current quarter as compared to a loss before taxation of approximately RM9.40 million for the quarter ended 31 December 2008. This was mainly due to the recognition of impairment on the property development segment, and the recognition of a revised settlement charge of RM3.17 million, during the immediate preceding quarter.

B3. COMMENTARY ON PROSPECTS

The Directors are of the view that the performance of the Group hinges substantially on the performance of its subsidiaries namely Jernih Makmur Sdn Bhd (Principal activity – logging and selling of round end timber logs) and Consistent Harvest Sdn Bhd (Principal activity – renting of shopping spaces in its shopping complex) and the joint venture property development with Creative Springs Sdn. Bhd. Barring any unforeseen circumstances, the Directors expect that a better performance of the Group can be achieved in the remaining period of the current year.
