## Part A – Explanatory Notes Pursuant to FRS 134

#### A1. BASIS OF PREPARATION

The interim financial statements have been prepared under the historical cost convention except for the financial assets and investment properties which were stated at fair values.

The interim financial statements were unaudited and have been prepared in accordance with requirements of the Financial Reporting Standards ("FRS") 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 December 2009. The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that were significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2009.

#### A2. CHANGES IN ACCOUNTING POLICIES

The significant accounting policies adopted were consistent with those of the audited financial statements for the year ended 31 December 2009 except for the adoption of new standards, amendments to standards and IC interpretations that are mandatory for the Group for the financial year beginning 1 January 2010. The adoption of these standards, amendments and interpretations do not have a material impact on the interim financial information of the Group except for the adoption of the following standard as set out below:

Presentation of financial statements (FRS101 (revised) "Presentation of financial statements")

The revised standard prohibits the presentation of items of income and expenses (that is 'non-owner changes in equity') in the statement of changes in equity, requiring 'non-owner changes in equity' to be presented separately from owner changes in equity. All 'non-owner changes in equity' are required to be shown in a statement of comprehensive income which can be presented as a single statement or two statements (comprising the income statement and statement of comprehensive income). The Group has elected to present the statement of comprehensive income in a single statement.

### **B1. PERFORMANCE REVIEW**

For the current financial period ended 30 June 2010, the Group's revenue was RM2.17 million compared to RM8.01 million in the preceding financial period ended 30 June 2009. The decrease in revenue was mainly due to the minimum activities from timber extraction segment and joint venture project of investment holding segment during the financial period.

The Group recorded a loss before tax of approximately RM1.07 million as compared to a loss before tax of approximately RM0.01 million for the corresponding preceding financial period ended 30 June 2009.

### B2. COMMENT ON MATERIAL CHANGE IN PROFIT BEFORE TAXATION

The Group's recorded loss before taxation of approximately RM0.61 million for the current quarter as compared to a loss before taxation of approximately RM0.45 million for the quarter ended 31 March 2010. There were no material differences in the results as compared to the immediate past quarter.

### **B3.** COMMENTARY ON PROSPECTS

The Directors are of the view that the performance of the Group hinges substantially on the performance of its subsidiaries namely Jernih Makmur Sdn Bhd (Principal activity – logging and selling of round end timber logs) and Consistent Harvest Sdn Bhd (Principal activity – renting of shopping spaces in its shopping complex) and the joint venture property development with Creative Springs Sdn. Bhd. Barring any unforeseen circumstances, the Directors expect that they will be able to achieve better performance for the Group in the remaining period of the current year.
