EXPLANATORY NOTES TO THE INTERIM FINANCIAL REPORT

1. BASIS OF PREPARATION

The interim financial statements are unaudited and have been prepared in accordance with MFRS 134, *Interim Financial Reporting* and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad and should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 March 2018 and the accompanying notes attached to the unaudited condensed consolidated financial statements.

2. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies and methods of computation adopted for the interim financial report are consistent with those adopted for the annual audited financial statements for the financial year ended 31 March 2018 except for the adoption of the following new /amended standards which are applicable to the Group with effect 1 April 2018:

- MFRS 9, Financial Instruments (2014)
- MFRS 15, Revenue from Contracts with Customers
- Clarifications to MFRS 15, Revenue from Contracts with Customers
- IC Interpretation 22, Foreign Currency Transactions and Advance Consideration
- Amendments to MFRS 128, Investment in Associates and Joint Ventures (Annual Improvements to MFRS Standards 2014-2016 Cycle)
- Amendments to MFRS 140, Investment Property Transfers of Investment Property

The adoption and application of the above standards are not expected to have any material impact to the financial statements of the Group except as mentioned below:

(a) MFRS 9, Financial Instruments

The Group adopted MFRS 9, *Financial Instruments* on 1 April 2018. MFRS 9 replaces the guidance in MFRS 139 Financial Instruments, Recognition and Measurement on the classification and measurement of financial assets and financial liabilities and on hedge accounting.

MFRS 9 contains a new classification and measurement approach for financial assets that reflects the business model in which assets are managed and their cash flow characteristics.

The new standard contains three principles classifications categories for financial assets: measured at amortised cost, fair value through other comprehensive income (FVOCI) and fair value through profit and loss (FVTPL). The standard eliminates the existing MFRS 139 categories of held to maturity, loans and receivables and available for sale.

2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(a) MFRS 9, Financial Instruments (continued)

The Group has estimated the financial impact upon initial application of the new impairment model. As allowed by the transitional provision of MFRS 9, the Group elected not to restate the comparatives. Adjustments arising from the initial application of the new impairment model has been recognised in the opening retained earnings as at 1 April 2018 as disclosed below:

(b) MFRS 15, Revenue from Contracts with Customers

MFRS 15 replaces the guidance in MFRS 111, Construction Contracts, MFRS 118, Revenue, IC Interpretation 13, Customer Loyalty Programmes, IC Interpretation 15, Agreements for Construction of Real Estate, IC Interpretation 18, Transfers of Assets from Customers and IC Interpretation 131, Revenue - Barter Transactions Involving Advertising Services. MFRS 15 provides a single model for accounting for revenue arising from contracts with customers, focusing on the identification and satisfaction of performance obligations. The standard specifies that the revenue is to be recognised when control over the goods or services is transferred to the customer, moving from the transfer of risk and rewards.

With the adoption of MFRS 15, revenue is recognised by reference to each distinct performance obligation in the contract with customer. Transaction price is allocated to each performance obligation on the basis of the relative standalone selling prices of each distinct goods or services promised in the contract. Depending on the substance of the contract, revenue is recognised when the performance obligation is satisfied, which may be at a point in time or over time.

Effective 1 April 2018, the Group recognises revenue in accordance to MFRS 15, *Revenue from Contracts with Customers*. The initial application of this accounting standard is not expected to have any material financial impact to the current period and prior period financial statements of the Group.

3. SEASONALITY OR CYCLICALITY OF OPERATIONS

The Group's operations are not subject to any significant seasonal factors except that mail volume fluctuates during the festive season and at the beginning of calendar year.

4. ITEMS OF UNUSUAL NATURE, SIZE OR INCIDENCE

There was no material item of an unusual nature, size or incidence affecting the assets, liabilities, equity, net income or cash flows during the financial period ended 30 September 2018.

5. CHANGES IN ESTIMATES

There was no material change in the estimate of amount reported in prior financial period that has a material effect to this interim financial report except as disclosed in Note 2 (a).

6. ISSUANCE OR REPAYMENT OF DEBT AND EQUITY SECURITIES

There was no issuance and repayment of debt and equity securities, shares held as treasury shares and resale of treasury shares for the financial period ended 30 September 2018.

7. DIVIDENDS PAID

There was no dividend paid for the current financial period ended 30 September 2018.

8. SEGMENTAL INFORMATION

The Group has five reportable segments, as described below, which are the Group's strategic business units. The strategic business units offer different products and services, and are managed separately because they require different business processes and customer needs. For each of the strategic business units, the Group's Chief Executive Officer (the chief operating decision maker) and the Board of Directors review internal Management reports at least on a quarterly basis. The following summary describes the operations in each of the Group's reportable segments:

Postal Services	Includes the provision of basic mail services for corporate and individual customers and customised solutions such as Mailroom Management and Direct Mail and over-the-counter services for payment of bills and certain financial products and services.
Courier	Includes the courier, parcel and logistic solutions by sea, air and land to both national and international destinations.
International	Includes the direct entry and transhipment.
Logistics	Includes haulage services, freight and forwarding, shipping agency and chartering services, warehousing and distribution services.
Aviation	Includes cargo and ground handling, in-flight catering, freight and forwarding and air cargo transport.

8. SEGMENTAL INFORMATION (CONTINUED)

Other segment includes the hybrid mail which provides data and document processing services, business of internet security products, solutions and services, Ar Rahnu business including storage and safekeeping fees, buying and selling of investment precious metals, namely gold bars and dinars and rental income from investment properties held by the Group. None of these segments meets any of the quantitative thresholds for determining reportable segments in the current reporting period.

There are varying levels of integration between the Postal Services reportable segment and the Courier reportable segment. This integration includes shared distribution services. The accounting policies of the reportable segments are the same as described in Note 2.

Information regarding the operations of each reportable segment is shown below. Performance is measured based on segment results. Segment results is used to measure performance as Management believes that such information is most relevant in evaluating the results of certain segments relative to other entities that operate within these industries. Inter-segment pricing is determined on a negotiated basis.

Upon the completion of the liquidation exercise, the above companies will cease to be subsidiary companies of the Group. There was a minimal financial impact arising from the deconsolidation of subsidiary companies as above to the Group's assets and liabilities.

11.2 On 18 September 2018, PNSL Berhad (a wholly owned subsidiary of the Group), acquired 49% equity interest in Parcel Tankers Malaysia Sdn. Bhd. ("PTM") previously held by Yuma Shipping Pte. Ltd. ("YUMA") for a total consideration of RM2,403,000, increasing its ownership from 51% to 100%.

14. REVIEW OF GROUP PERFORMANCE

14.1 Group performance for the financial period ended 30 September 2018

The Group recorded lower revenue of RM1,179.2 million for the financial period ended 30 September 2018 as compared to RM1,198.8 million in the previous corresponding period ended 30 September 2017. This represents a decrease of RM19.6 million or equivalent to 1.6%.

(i) Postal Services

Postal Services registered lower revenue of RM333.4 million as compared to RM369.2 million. This is due to continuous decline in traditional mail volume largely due to electronic substitution.

(ii) Courier

Courier recorded higher revenue of RM419.5 million compared to RM363.7 million registered in the previous corresponding period ended 30 September 2017. This continues the upward performance seen in previous year, and mainly driven by increased demand in e-Commerce as well as online business customers.

(iii) International

International revenue dropped by RM11.0 million largely due to lower volume in transhipment pursuant to a loss in one major customer's account.

(iv) Logistics

Logistics registered lower revenue by RM45.9 million mainly from the drop in project logistics namely Refinery and Petrochemical Integrated Development Project ("RAPID") in Pengerang as it is in the last stage of completion.

(v) Aviation

Aviation increased by RM17.9 million compared to previous corresponding period ended 30 September 2017 mainly contributed by higher tonnage of cargo handled.

(vi) Others

Other segments which consist of printing and insertion, digital certificates and Ar Rahnu, generated a marginal increase in revenue of RM0.6 million mainly due to higher printing and insertion and Ar Rahnu business.

(b) Group Profit Before Tax

For the financial period ended 30 September 2018, the Group registered a loss before tax of RM6.0 million from a profit of RM66.7 million in the corresponding period ended 30 September 2017. The drop is due to lower revenue registered from postal services, international and logistics segments coupled with the increase in costs namely cost of sales and operating expenses as well as finance costs.

14.2 Group performance for the financial quarter ended 30 September 2018

The Group recorded a slightly higher revenue of RM588.7 million for the financial quarter ended 30 September 2018 as compared to RM587.1 million in the previous corresponding quarter ended 30 September 2017. This represents an increase of RM1.6 million or equivalent to 0.3%.

(i) Postal Services

Postal Services registered lower revenue of RM161.4 million as compared to RM176.4 million. This is due to continuous decline in traditional mail volume largely due to electronic substitution.

(ii) Courier

Courier recorded higher revenue of RM215.0 million compared to RM182.1 million registered in the previous corresponding quarter ended 30 September 2017. This continues the upward performance seen in previous year, and mainly driven by increased demand in e-Commerce as well as online business customers.

(iii) <u>International</u>

International revenue dropped by RM1.1 million largely due to lower volume in transhipment pursuant to a loss in one major customer's account.

(vi) Logistics

Logistics registered lower revenue by RM21.1 million mainly from the drop in project logistics namely Refinery and Petrochemical Integrated Development Project ("RAPID") in Pengerang as it is in the last stage of completion.

(v) <u>Aviation</u>

Aviation increased by RM7.5 million compared to previous corresponding quarter ended 30 September 2017 mainly contributed by higher tonnage of cargo handled.

(vi) Others

Other segments which consist of printing and insertion, digital certificates and Ar Rahnu, generated a decrease in revenue of RM1.6 million mainly due to lower revenue from printing and insertion business.

(b) Group Profit Before Tax

For the financial quarter ended 30 September 2018, the Group registered a loss before tax of RM19.0 million from a profit of RM23.3 million in the corresponding quarter ended 30 September 2017. The drop is due to lower revenue contribution from postal services, international and logistics segments coupled with the increase in costs namely cost of sales and operating expenses as well as finance costs.

15. COMPARISON WITH PRECEDING QUARTER'S RESULTS

The group recorded a loss before tax of RM19.0 million in the current quarter ended 30 September 2018 compared to a profit of RM13.0 million in the preceding quarter ended 30 June 2018 mainly due to higher cost of sales and operating expenses amounting to RM39.3 million.

16. FUTURE PROSPECTS

The robust growth in e-Commerce continues to be the key revenue generator for our Courier business segment. This is driven by our extensive last-mile network and infrastructure in the country.

Conversely, our Postal Services business segment is facing unprecedented challenges due to the accelerating decline in mail volumes and also lower retail transactions at our post offices. This is a result of the increasing use of electronic substitute for mail and the availability of online and mobile bill payment and remittance services. To partly address the mail volume decline, we are focusing on increasing the sales of our postal offerings for e-Commerce customers to cater to the needs of their customers who do not require express delivery while retaining track and trace capabilities.

Industry overcapacity and fiscal consolidation are likely to cloud the prospects of our Logistics business segment. To partly address this, we plan to consolidate our logistic assets in line with industry conditions while at the same time, secure new customers in new market segments such as the transportation of bulk commodities.

Our Aviation business segment's prospects remain moderately upbeat in light of the expected passenger traffic growth of about 6% to 7% for 2018 and also higher air cargo volume growth. However, the passenger and ground handling businesses are competitive and therefore enhancing efficiency is key to sustainability.

Overall, we are optimistic that our Courier and Aviation businesses will continue to drive the Group's revenue growth. However, we are also mindful that there are substantial challenges in our Postal Services, International and Logistics businesses that could dilute the results of the Group if these challenges persist.

The Group has not issued any profit forecast or profit guarantee for the current financial period in a public document.
