The Group recorded higher revenue of RM12.6 million and loss before tax ("LBT") of RM2.8 million for the period ended 30 June 2011, compared with revenue of RM10.3 million and LBT of RM2.1 million for the corresponding period last year. The higher revenue in the period under review was mainly contributed from the higher brokerage fee income and advisory fee income. However, the higher LBT in the period under review was mainly due to lower other operating income.

B2. Comparison with Preceding Quarter's Results

The Group recorded revenue of RM5.0 million and LBT of RM3.3 million for the current quarter compared with the revenue of RM7.5 million and profit before tax of RM0.6 million recorded in the preceding quarter. The results in the current quarter were mainly affected by lower brokerage fee income, lower other operating income and substantial fair value loss on short term quoted investments recorded by the Group.

B3. Year 2011 Prospects

The Group expects the business environment to remain challenging. Various initiatives are in place to meet these challenges and to improve the volume of brokerage business for the current financial year. The Group continues to look forward to improving income from its corporate finance activities and asset management business.
