B. ADDITIONAL INFORMATION REQUIRED PURSUANT TO THE BURSA SECURITIES MAIN MARKET LISTING REQUIREMENTS

B1. Review of Performance

The Group recorded revenue of RM15.8 million for the period ended 30 September 2013 compared with the revenue of RM13.9 million for the same period last year. The higher revenue of the Group in the period under review was mainly due to higher gross brokerage income and interest income from margin financing.

The gross brokerage income of the Group increased by 8.3% compared to the same period last year due to higher trading activities in the second and third quarter of 2013. Interest income from margin financing also increased by 94.18%.

Loss before tax ("LBT") for the period ended 30 September 2013 was RM0.73 million, increased from RM0.68 million for the same period last year mainly due to lower debt recovery.

B2. Comparison with Preceding Quarter's Results

The Group recorded revenue of RM6.0 million and LBT of RM0.29 million for the current quarter compared with the revenue of RM7.1 million and profit before tax ("PBT") of RM0.2 million recorded in the preceding quarter. The Group recorded LBT for the current quarter mainly due to lower revenue.

B3. Year 2013 Prospects

Despite the challenging global economy, the Malaysian economy is expected to grow between 4.5% and 5.0%. The Group expects the business environment for the financial year ending 31 December 2013 to be challenging. Nevertheless, the Group will strengthen its stockbroking activities with various strategies to improve its financial performance. These include plans to rationalise its branch network, enlarge its team of dealer's representatives, participate more actively in IPO financing and increase the use of margin financing.

B7. Status of Corporate Proposals

On 26 February 2013, the Board announced that the Company is considered a Practice Note 17 ("PN17") company pursuant to Paragraph 2.1(a) of PN17 and Paragraph 8.04 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.

The PN17 criteria was triggered as a result of the Company's latest unaudited financial statements for the financial year ended 31 December 2012 that was announced on 26 February 2013 stating that the Company's shareholders' equity on a consolidated basis is 25% or less of the issued and paid-up capital and such shareholders' equity is less than RM40 million.

On 1 November 2013, the Board of Directors of the Company has announced that the Company is still in the process of formulating a plan to regularise the Company's financial condition. The Company has approximately three (3) months to submit its Regularisation Plan to the relevant authorities for approval.

Other than the above, there are no outstanding corporate proposals as at the date of this report.

Proceedings have been and will be initiated by PM Securities Sdn. Bhd. and Pan Malaysia Equities Sdn. Bhd. against various clients and debtors whose accounts are in default or overdue. As at 1 November 2013, these subsidiaries have filed claims against various clients and debtors in the aggregate sums of RM32.6 million together with interest and costs.

Two claims totalling RM600,620 were brought by the customers of the stockbroking subsidiary for recovery arising from fraudulent conduct by an ex-remisier. The subsidiary is appealing against the decisions of the Court.
