



The Acquisitions entail the acquisition by Glomac of:

- (i) the remaining 49% of the issued and fully paid-up share capital of Glomac Sutera comprising 490,000 ordinary shares of RM1.00 each for a consideration of RM490,000. In addition, Glomac will assume the advances from the vendors of Glomac Sutera amounting to RM8,247,249. The aggregate amount due to the vendors amounting to RM8,737,249 was satisfied by the issue of 4,628,638 Glomac Shares at RM1.25 per share and cash settlement amounting to RM2,951,452; and
- (ii) 100% of the issued and paid-up share capital of Glomac Vantage comprising 3,900,000 ordinary shares of RM1.00 each for a total cash consideration of RM3,900,000. The 3,900,000 ordinary shares of RM1.00 each in Glomac Vantage includes 1,400,000 ordinary shares of RM1.00 each issued to Centrocom Sdn Bhd, an existing shareholder of Glomac Vantage pursuant to the capitalisation of RM1,400,000 of advances made by Centrocom Sdn Bhd to Glomac Vantage. The capitalisation was carried out on 1 February 2000. The directors of Glomac namely Dato' Mohamed Mansor bin Fateh Din and Fong Loong Tuck, have jointly undertake to personally settle the cash consideration of RM3,900,000 on behalf of Glomac, thereby resulting in an amount owing to the directors of Glomac which will be set-off against the existing amount owing by the directors of Glomac to Glomac.
